
We have received your claim in the amount of \$424.97, relating to damage allegedly sustained to your vehicle on June 30, 2004 when you allege its bumper was backed into by a garbage truck while picking up trash behind 3123 North 40th Street.

Our investigation reveals the Fleet Accident Report completed as a result of this alleged incident notes that there was no paint transfer of impact marks on your vehicle. In addition, the driver of the garbage truck denies damaging your vehicle. Since there is no evidence to support your belief that a City garbage truck caused the damage, the City cannot accept liability. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
