Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. ## Narrative (1)

### LICENSED PREMISE REPORT

This report is written by *P.O Jordan EMMONS*, assigned to District One, Day Shift, 1164, (*Community Partnership Unit*).

On Wednesday, 11/01/2023, at 3:00PM, I responded to 1348 E. Brady St. (QDOBA) for a License Premise Check, and to meet with the City of Milwaukee Health Department.

*This same date at 1:30PM, I was advised the City of Milwaukee Health Department, Consumer Enviromental Health Manger Kristin CASTILLO, they received a tip from a citizen that a razor blade had been located in a burrito from Qdoba (1348 E. Brady St.). I was asked to meet with Health Inspectors at 3:00PM while they conducted their investigation.*

Upon my arrival, I met with City of Milwaukee Health Inspector Pat Doornek and Paige Okray. *Pat advised me a citizen named Scott Fiewert (608-886-1117) contacted their department regarding locating a razor blade in their burrito purchased on 10/31/2023 from Qdoba (1348 E. Brady St.). Fiewert stated he ate one burrito in the restaurant and brought the other one home. Fiewert advised the health department that he warmed up the other burrito and located a blade horizontal in orientation in the middle of the burrito. Fiewert provided the health department pictures of the razor blade, food, and of the receipt from this transaction dated 10/31/2023 at 1:27PM. Both burritos were prepared and made in front of and in view of Fiewert.*

I spoke to general manager, identified as Pedro L. GARCIA (W/M 10/27/1975). GARCIA stated he was working the day and time this order was filled on his off day to help out. Based on the receipt GARCIA stated this was an order made in front of the customer. GARCIA was shown a photograph of the razor and did not recognize it as being from their restaurant. He showed us two hook style safety cutters they have, where the razor blade was encased inside plastic. Pat Doornek from the Health Department observed one of the safety cutters was in poor condition.

*Comparing the actual razor found in Fiewert's food to the safety cutters that were in store, it was an exact match to the razor inside their safety cutters. It was determined the razor blade made it into the food by accident after a razor slipped out of the plastic encasing of their safety cutter.*

While on scene, I observed the licenses posted and they were up to date. During my investigation I did not observe any violations in the licensed premise. The City of Milwaukee Health Department will be filing their own report regarding.

## **Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:**

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.  
**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**
