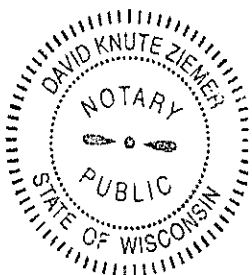

090216... A substitute ordinance relating to a change in zoning from General Planned Development to a Detailed Planned Development known as Shiloh Manor, for a 45-unit housing development for seniors, on land located

East of North Dr. Martin Luther King Jr. Drive and South of West Keefe Avenue, in the 6th Aldermanic District.

090352... A substitute charter ordinance relating to review and approval of certain city contracts.

090428... A substitute ordinance relating to vacant building registration and requirements.

090445... A substitute ordinance to further amend the 2009 rates of pay of offices and positions in the City Service.

090446... A substitute ordinance to further amend the 2009 offices and positions in the City Service.

090535... A substitute ordinance relating to a change in zoning from Industrial-Light to a Detailed Planned Development known as Milwaukee's Asian Markets-Phongsavan, on land located East of North 76th Street and South of West Mill Road, in the 2nd Aldermanic District.
