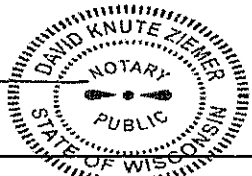

Notice is hereby given that an ordinance that was introduced at the February 27, 2013 meeting of the Milwaukee Common Council, the essence of which is as follows:

A substitute ordinance relating to the change in zoning from Multi-Family Residential to Two-Family Residential on lands located north of West Wisconsin Avenue, between North 27th Street and North 29th Street, in the 4th Aldermanic District.

Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-501.2(b).0004. The zoning map is amended to change the zoning for 2708 West Wisconsin Avenue, Tax Key No. 388-1101-000; 2812 West Wisconsin Avenue, Tax Key No. 388-1106-100; 2830 West Wisconsin Avenue, Tax Key No. 388-0310-100; 2838 West Wisconsin Avenue, Tax Key No. 388-2009-110; 2805 West Wells Street, Tax Key No. 388-0107-113; and 763 North 28th Street, Tax Key No. 388-0311-112, from Multi-Family Residential (RM7) to Two-Family Residential (RT3).

Notice is hereby further given that the foregoing matter will be given a public hearing by the Committee on Zoning, Neighborhoods and Development in Room 301-B, City Hall, 200 East Wells Street, Milwaukee, Wisconsin, on Tuesday, April 23, 2013 at 9:00 A.M., pursuant to the

provision of Sub-Section (7)(d) of Section 62.23 of the Revised Statutes of the State of Wisconsin.

PLEASE NOTE: a) Members of the Common Council, and members of its Standing Committees who are not members of this Committee, may attend this meeting to participate or to gather information. Therefore, notice is given that this meeting may constitute a meeting of the Common Council or any of its Standing Committees, and must be noticed as such, although they will not take any formal action at this meeting.
