The complainant, T. ANTHONY ZIELINSKI, individually and in his capacity of Alderman in the 14th Aldermanic District (collectively "Complainant"), alleges of the above-named respondent as follows:

#### **Introduction and Parties**

The Complainant is an adult resident of the 14th Aldermanic District in the City of 1. Milwaukee and resides at 2463 South Superior Street in the City. Complainant is also the duly elected and acting Alderman for such district and maintains an office for conducting constituent

business in his position of Alderman in Room 205 - City Hall, 200 East Wells Street, Milwaukee, Wisconsin.

- 2. That Respondent Allan J. Wasley ("Wasley"), is an adult resident of Waukesha County and resides at 1408 American Avenue, Waukesha, Wisconsin 53188. Wasley is currently the agent for the purposes of the Class B Tavern License and the Tavern Dance License (the "Licenses") issued for the licensed premises at 3164 South 13th Street, in the City of Milwaukee (the "Licensed Premises").
- 3. That Respondent Wolfgang's Pub, LLC¹ ("Wolfgang's"), is, upon information and belief, a Wisconsin limited liability company (State ID No. W046378) of which Wasley is the licensed corporate agent and has its home office and principal place of business at 1408 American Avenue, in the City of Waukesha, as of May 12, 2005.
- 4. That, upon information and belief, Wolfgang's is the owner or lessee of the Licensed Premises where it operates a tavern and dance hall.

#### **Jurisdiction**

5. This Verified Complaint is filed in accordance with § 90-12-4, *Milwaukee Code of Ordinances ("MCO")* and the revocation proceedings are authorized by § 90-12, *MCO* and §§ 125.12 (2) (ag) to (c), <u>Wis. Stats.</u>

## **Underlying Facts Justifying Revocation**

6. That on Tuesday, February 8, 2005 at 1:45 p.m., the Utilities and Licenses Committee of the Common Council of the City of Milwaukee (the "Committee") conducted a public hearing in

the matter of the Class B Tavern License and Dance License applications of Respondent Wasley as agent for Respondent Wolfgang's, and despite a substantial police objection to the Licensed Premises and a report of criminal record dated January 5, 2005 of Respondent Wasley<sup>2</sup>, was granted the requested Licenses.

- 7. Since that time, serious illegal and inappropriate conduct contrary to § 90-12-1-(a.) thru (i.), *MCO*, has continued to occur at the Licensed Premises so as to become a serious public nuisance and a substantial safety hazard to the surrounding neighborhood in general, and the immediate neighbors of the Licensed Premises in particular. As such, the Licensed Premises is no longer fit for utilization as a Class B Tavern or Tavern Dance Hall. By reason of the continuing criminal conduct as set forth hereinafter, the Licenses should promptly be revoked and the Licensed Premises be permanently closed by the appropriate authority.
- 8. The various acts precipitated by the Respondents in the operation of their business and which required regular police activity and intervention as follows:
- a. Regular congregation during evening and late hours of customers and gang members in the immediate vicinity of the Licensed Premises accompanied by public drinking, loud noises, loud music, fowl and profane language, public insults to neighbors in the vicinity, public urination and loitering.
- b. Littering the streets and sidewalks in the immediate vicinity of the Licensed Premises and on the surrounding and largely residential properties consisting of papers, food

wrappers, beer cans, broken beer and liquor bottles, boxes and general trash during all hours that the Licensed Premises was open for business.

- c. Reckless driving, traffic obstruction, racing, illegal parking, spinning tires, blowing car horns and car stereos at maximum volumes with the car windows open, particularly in the later hours and especially at closing time.
- d. Allowing patrons to congregate in the parking lot and on the street and sidewalk in front of the Licensed Premises which involved various loud noises, drinking, playing of music at high volume, fighting, throwing objects, wrestling and scuffling, and other generally disorderly conduct.
- e. That on May 14, 2005, in the late evening of that day and the early morning of the next day, at least 8 customers who arrived at the Licensed Premises and were drinking, began an argument with another patron, Harlem L. Sewell (the "Victim"). As a result of the argument, the 8 individuals began to beat up the Victim and dragged him into the parking lot where the beating continued. The beating them continued and spilled over into the street. The Victim was seriously injured and denied starting the fight. *See* Exhibit C. In addition, the fight drew out other customers into the parking lot and into the street and attracted even further patrons who were coming to the Licensed Premises, resulting in a substantial disturbance to the neighborhood. At that date and time, the Respondent Wasley was not present at the Licensed Premises.
- f. That on or about August 20, 2005, at the Licensed Premises, the person in charge of the Licensed Premises at that time permitted at least one individual in the early evening to loiter on the Licensed Premises and to obtain alcohol while that person, in fact, was under the age

of 21 years. Civil Citation No. 59026494 was issued. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit D.

- g. That on or about August 20, 2005, at approximately 1:00 a.m., an unknown assailant in possession of a 9mm semi-automatic handgun who was then a customer on the Licensed Premises, fought with and ultimately shot to death Daniel (nmn) Vela ("Victim #1"), age 32 years, in the men's room of the Licensed Premises and escaped in possession of the weapon. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit E.
- h. That on or about August 20, 2005, at approximately 1:00 a.m., an unknown assailant in possession of a 9mm semi-automatic handgun who was then a customer on the Licensed Premises, fought with and fired a ultimately shot to death Roberto Vela, Jr. ("Victim #2"), age 31 years, in the men's room of the Licensed Premises and escaped in possession of the weapon. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit E.
- i. That on or about August 20, 2005, at approximately 1:00 a.m., an unknown assailant in possession of a 9mm semi-automatic handgun who was then a customer on the Licensed Premises, fought with and fired a shot at death Armando (nmn) Pena (Victim #3), age 19 years, and pursued him through the Licensed Premises and out on to the street in front of the Licensed Premises where he was shot and critically injured. Emergency services promptly removed the Victim Pena to Froedtert Memorial Hospital where he was pronounced dead at 9:02 a.m. on August 20, 2005. The assailant escaped in possession of the weapon. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit E.
- j. That on or about Saturday, August 20, 2005, at approximately 10:30 p.m., three female dancers were observed at the Licensed Premises performing nude dancing without the

proper cabaret license in violation of § 90-22-1-a. to d., *MCO*. Civil Citation No. 5902650-3 was issued to the Respondent Wasley by the Milwaukee Police Department. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit F.

- k. That on or about Saturday, August 20, 2005 at 10:30 p.m. the Respondent Wasley allowed and permitted certain underage persons to loiter and consume alcohol beverages at the Licensed Premises in violation of § 90-10, *MCO*. Citation No. 5902649-4 was issued to the Respondent Wasley by the Milwaukee Police Department. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit F.
- l. That on or about Saturday, August 20, 2005 at approximately 10:30 p.m. the Respondent Wasley allowed and permitted one Veronica C. Gonzalez, a person under the age of 21 years, to loiter and to consume alcohol beverages on the Licensed Premises. Citation No. 5903975-0 was issued to Veronica C. Gonzales by the Milwaukee Police Department. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit F.
- m. That on or about Saturday, August 20, 2005 at approximately 10:30 p.m. the Respondent Wasley allowed and permitted one Jonathan E. Lindquist, a person under the age of 21 years, to loiter and to consume alcohol beverages on the Licensed Premises, for which Citation No. 5903972-4 was issued by the Milwaukee Police Department to the minor Jonathan E. Lindquist. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit F.
- n. That on or about Saturday, August 20, 2005 at approximately 10:30 p.m. the Respondent Wasley allowed and permitted one Dominique L. Williams, a person under the age of 21 years, to loiter and to consume alcohol beverages on the Licensed Premises. Citation No.

5903974-6 was issued to Dominique L. Williams by the Milwaukee Police Department. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit F.

- o. That on or about Saturday, August 20, 2005 at approximately 10:30 p.m. the Respondent Wasley allowed and permitted one Christine A. Schroedl, a person under the age of 21 years, to loiter and to consume alcohol beverages on the Licensed Premises. Citation No. 5903971-3 was issued to Christine A. Schroedl by the Milwaukee Police Department. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit F.
- p. That the Respondent Wasley permitted and allowed a minor, one Christine A. Schroedl, to perform nude at the Licensed Premises in violation of § 90-22-2-a. to d., *MCO*. Citation No. 5903973-5 was issued by the Milwaukee Police Department to Christine A. Schroedl, a minor. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit F.
- q. That on or about Saturday, August 20, 2005, at 10:30 p.m. the Respondent Wasley allowed and permitted a minor, one Veronica C. Gonzales, to perform nude at the Licensed Premises in violation of § 90-22-2-a. to d., *MCO*. Citation No. 5903976-1 was issued by the Milwaukee Police Department to Veronica C. Gonzalez, a minor. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit F.
- r. That on or about Saturday, August 20, 2005, at 10:30 p.m. the Respondent Wasley allowed and permitted the rear door to be locked with a deadbolt during hours of operations of the Licensed Premises, which interfered with safe egress from the Licensed Premises in violation of § 90-27-1-d., *MCO*. Citation 5903978-3 was issued to the Respondent Wasley. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit F.

- s. That on or about Saturday, August 20, 2005, at 10:30 p.m. the Respondent Wasley allowed limited accessibility to the Licensed Premises by causing and allowing the entrance door near the front of the Licensed Premises to be locked on the inside in violation of § 90-27-1, *MCO*. Citation No. 5903979-4 was issued to the Respondent Wasley. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit F.
- t. That on or about Saturday, August 20, 2005 at 10:30 p.m. the Respondent Wasley allowed and permitted four (4) additional under age youths to loiter and consume alcohol at the Licenses Premises in violation of § 90-19, *MCO*. Citation No. 5903980-5 was issued by the Milwaukee Police Department to the Respondent Wasley. At that date and time, the Respondent Wasley was not present at the Licensed Premises. *See* Exhibit F.
- 9. That all of the above and foregoing conduct and conditions at the Licensed Premises renders it unfit to serve as Licensed Premises and inappropriate for the Respondent Wasley to operate Wolfgang's Pub as a Class B Tavern or a Tavern Dance Hall. Repeated violations of Chapter 90, *MCO*, reveal a pattern of conduct that constitutes a public nuisance and a substantial safety hazard to patrons at the Licensed Premises and people living in the neighborhood around the Licensed Premises. *See* Exhibit F.
- 10. That additional substantial evidence in addition to the foregoing and evidence supporting the foregoing allegations, are contained in the files of the Committee and in the Office of the City License Clerk, which the Committee is requested to consider. <u>See</u> §§ 909.015(7) and 910.05, <u>Wis. Stats.</u> (*Wis. Rules of Evidence*).

WHEREFORE, Complainant requests that upon the filing of this Verified Complaint, a Summons to the Respondents be issued by the City Clerk demanding that Respondents appear before

the Committee in accordance with § 90-12-5(a.), *MCO*, and show cause why the Licenses should not be revoked, that such Summons and a copy of this Verified Complaint be promptly served upon the Respondents, that the Committee convene and take testimony and based thereon, make specific Findings of Fact and Conclusions of Law, to be submitted to the Common Council and thereafter the Licenses of the Respondents be revoked and the Licensed Premises closed permanently.



#### NARRATIVE:

This report is being dictated by Squad 138, Lieutenant of Detectives Kenneth R. GRAMS, and is based upon crime scene investigation and witness interviews.

On Saturday, 8-20-05, at 1:08 AM, Squad 2R, Sergeant COLON, Squad 902C, Sergeant RADAN, and Squad 23, P.O.'s ADKINS and SLOMCZEWSKI, were dispatched to a shooting at Wolfgang's Pub, 3164 S. 13<sup>th</sup> St. Upon arrival, a preliminary investigation revealed that there was a triple shooting consisting of two deceased white male subjects in the men's bathroom area at this location, and a third white male subject who had sustained a gunshot wound to the head, and had been lying on the city sidewalk directly in front of Wolfgang's Pub at 3164 S. 13th St. Preliminary investigation revealed that victim #1, Daniel VELA, was located within the men's bathroom and was PNB upon the arrival of the officers, and had sustained one non-exiting qunshot wound to the left forehead area. Victim #2, Roberto VELA, also was located within the men's bathroom area, was PNB upon the arrival of the officers, and had sustained two gunshot wounds consisting of one non-exiting qunshot wound to the lower left abdomen, and one non-exiting gunshot wound to the right neck area. Victim #3, Armando PENA, had sustained one non-exiting gunshot wound to the center of his forehead area, and was breathing upon the arrival of officers; however, no statement was provided. Armando was treated by Med Squad 15,



manned by Battalion Chief Jack CHRISTENSON, and was conveyed to Froedtert Hospital, but died from his injuries at 9:02 AM.

Crime scene investigation conducted by Detective Shannon JONES revealed that the shooting transpired within Wolfgang's Pub, that there was a front entry doorway leading out onto S. 13th St., along with a rear exit doorway leading into the alleyway. interior of the tavern consisted of a bar located at the front portion of the tavern and a single pool table located at the rear of the establishment. There were a men's bathroom and a women's bathroom located adjacent the north center wall area. There were no functioning recording systems at this location. investigation revealed that there were four spent 9mm Luger casings recovered within the men's bathroom area, along with three Scene investigation directly in front of establishment where victim #3 had been shot and fallen to the concrete pavement revealed a large pooling of blood, and within the blood was one ring. Also on the sidewalk was a broken Corona beer bottle. Directly in front of the establishment was a light blue Chevy Caprice stationwagon, bearing Wisconsin registration 187DPN, which listed to a tavern patron, Eugene HANSON. The right front passenger window on this vehicle had been shattered, and it was unknown if this was caused by a bullet striking the window, or the victim hitting the window glass. This auto was conveyed to the PAB for processing, Tow #1229529. Additionally, one spent 9mm Luger casing was located in the roadway directly in front of this vehicle, and one bullet was located adjacent the southwest corner of the tavern.

Witness interviews revealed that there had been a party occurring within the tavern prior to this incident, during which time victims #1 and #2, who were cousins, were attending the party with victim #3. Also within the establishment was the suspect, and prior to the shooting, the suspect and victim #2, Roberto VELA, were engaged in a verbal and minor physical altercation near the front portion of the bar. Witnesses indicated that it



appeared that the suspect and the victim ceased their disagreement, during which time the victim Roberto purchased a drink for the suspect. Both the victim Roberto and the suspect then left the front portion of the bar and walked towards the rear pool area where victim #1, Daniel VELA, and victim #3, Armando Moments later, witnesses heard 4 to 5 PENA, were located. gunshots occurring from the rear portion of the bar, and then observed the suspect fleeing towards the front exit doorway, following victim #3, Armando PENA. Once outside of establishment, witnesses heard an additional one or two gunshots, and the suspect was then observed fleeing on foot in an eastbound direction through the southside parking lot towards W. Euclid.

The keywitness who had initially observed the brief verbal and physical altercation between Roberto and the suspect proceeded to the men's bathroom area and observed both victims, Roberto and Daniel, shot in the bathroom. Daniel was observed to be lying in a prone position, and appeared to be PNB. The victim Roberto was initially observed on his knees, positioned behind the bathroom door and the east bathroom wall. The keywitness dragged Roberto out into the common hallway and proceeded to perform CPR on victim #1, Daniel, and then provided CPR to victim #2, Roberto. Patrons advised the keywitness that his cousin, Armando PENA, was shot outside the tavern, at which time the keywitness proceeded to that location and provided CPR to PENA until the arrival of the Milwaukee Fire Department personnel.

Follow-up investigation is currently being conducted at the C.I.B. with keywitnesses in attempting to identify the suspect, along with identifying two male subjects and a female subject who may have fled the scene with the suspect.
