
We have received your claim in the amount of \$1,817.31, relating to damage sustained to your vehicle on March 22, 2005 when it was struck by debris that you allege flew from the top of a City truck while traveling on Lincoln Memorial Drive.

Our investigation reveals that the Fleet Accident Report completed as a result of this alleged incident notes that the driver did not find any objects missing from the tools and truck materials. In addition, everything was secured. The driver also denies leaving light bulbs on the roof of the truck. Since there is no evidence to support your belief that bulbs from a City truck caused the damage, the City cannot accept liability. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
