\$148,000 does not account for special military pays, such as housing allow ances and combat pay, as these were not available. Accounting for these

special military pays will reduce the fiscal estimate of \$148,000 for employees currently on military leave.

This resolution authorizes expenditures but does not provide for a funding source. It is anticipated that the vacancy savings that result from City personnel going on a leave of absence in order to serve on active duty will be offset by increased departmental expenses for overtime, special duty pay, and temporary employment services. Therefore, the funding for this benefit will have to come from either a Contingent Fund appropriation or by extending the duration of other vacancies that occur in City government.
