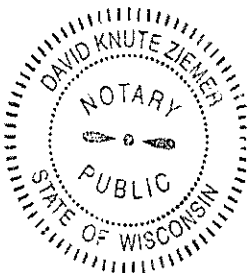

Leonhardt, City Clerk of the City of Milwaukee, certify that pursuant to Section 4-06-3 of the Milwaukee City Charter, notice is given of the passage of the following ordinances by the Common Council of the City of Milwaukee on 05/25/2010, with the approval of Mayor Tom Barrett. The full text of each of the ordinances listed below can be obtained at the Office of the City Clerk, Room 205, City Hall, 200 E. Wells Street, Milwaukee, Wisconsin, 53202.

**081568...** A substitute ordinance creating the Milwaukee River Greenway Site Plan Review Overlay Zone, generally located North of the former North Avenue Dam to the City Limits of East Silver Spring Drive in the 1st, 3rd and 6th Aldermanic Districts.

**081664...** A substitute ordinance relating to storm water management regulations applicable to properties within the Milwaukee River greenway site plan review overlay zone.

**090799...** A substitute ordinance to grant an airspace lease to RADR Corporation for an existing railroad bridge crossing E. Becher Street between 123 E. Becher Street and 128 E. Becher Street.

**091027...** A substitute ordinance relating to procedures for late filing of applications for carnival site permits and for special Class "B" short-term licenses for clubs.

**091371...** A substitute ordinance relating to restructuring and combining licenses for professional and street photographers, and public dance hall and shows and exhibitions, and repealing licenses for roller skate rentals on public premises and tag day permits.

**091609...** A substitute charter ordinance relating to retirement benefits for certain city employees.

**091615...** A substitute ordinance relating to encroachments, projections and special privileges.

**091646...** A substitute ordinance to further amend the 2010 rates of pay of offices and positions in the City Service.

**091647...** A substitute ordinance to further amend the 2010 offices and positions in the City Service.

**091658...** A substitute ordinance relating to private transportation reimbursement and travel regulations.

**091660...** A substitute ordinance relating to a change in zoning from Multi-Family Residential to Two-Family Residential, on land located East of North 25th Street and North of West State Street, in the 4th Aldermanic District.

**100019...** A substitute ordinance relating to parking controls.

**100020...** A substitute ordinance relating to traffic controls.

**100119...** A substitute ordinance relating to revision of various provisions of the code for purposes of correcting errors, clarifying language and eliminating obsolete provisions.
