Investigation revealed that two employees engaged in a physical fight, one of them left, and brought back a group of friends to re-fight the employee. The manager broke up the fight, the victim did not want to talk with police, and the police conveyed her to her residence.
2. On 10/05/22 at 6:20am, Milwaukee Police were dispatched to 633 W. North Avenue for a burglary complaint. Investigation revealed that a subject broke out a window to the door on the southside of the restaurant and entered the building. There was damage to the register, the place was ransacked, and the circuit breakers were switched off. Unknown what was taken.

Investigation revealed a customer was in the drive-thru and was getting their change back, when a subject they had previously been arguing with, grabbed the change and fled the scene. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

4. On 10/01/23 at 9:05p.m., Milwaukee Police were dispatched to a Fight at 633 W. North Ave. Investigation revealed two employees engaged in a physical altercation, however, it was broke up prior to police arrival. The business was cooperative.
5. On 11/03/23 at 10:21p.m., Milwaukee Police were dispatched to a Threat at 633 W. North Ave. Investigation revealed an employee made a comment to another employee, which was taken as a threat. The business was cooperative.

On Thursday, May 29, 2025 at 11:09A, my partner (P.O. Daniel TIERNEY) and I were dispatched to N. 7th St. and W. North Ave. regarding a battery complaint.

Upon arrival, several people were observed in the parking lot of Wendy's, 633 W. North Ave. The individuals were employees of the Wendy's and indicated a fight occurred inside of the restaurant. Upon entering the restaurant, I observed the dining area in disarray; chairs knocked over and beverages spilled on the ground. The manager, Wilhelmina K. MCKENZIE (B/F, 07-31-78) indicated several juveniles were inside of the restaurant eating when a second group of juveniles entered. MCKENZIE stated the second group approached the first group and described a black female juvenile, wearing pink pants, who began "macing" members of the first group. MCKENZIE stated both groups then began physically fighting in the dining area of the restaurant. MCKENZIE stated she and several other employees went into the dining area to break up the fight. MCKENZIE stated while attempting to break up the fight, the female in the pink pants picked up a chair and struck her on the right side of her face causing pain, redness and swelling. I did observe redness and swelling to MCKENZIE's face. MCKENZIE indicated they were finally able to remove all combatants from the restaurant. The following employees attempted to break up the fight and suffered the effects of the "mace":

Larissa A. THOMPSON (B/F, 11-06-75)

Jennifer L POTTINGER (B/F, 10-03-83)

David AKINES (B/M, 02-24-69)

Wilhelmina K. MCKENZIE (B/F, 07-31-78)

None of the other employees were injured during the incident. MCKENZIE stated she wished to pursue charges against the female who struck her with the chair. The District Manager, Markquesa L. ALEXANDER (B/F, 10-22-73) was on scene at the time of the investigation and provided us access to the restaurant's security cameras. I further emailed a link to ALEXANDER to download the video to Evidence.com.

THOMPSON indicated she took a picture of the license plate of the vehicle the female in the pink pants entered while leaving the location. The picture depicted a Wisconsin license plate of AYU-9489. A DOT check of the plate indicated it was registered to a Quincy V. SMITH (B/M, 01-28-05) of 5005 N. 23rd St. P.O. TIERNEY and I responded to 5005 N. 23rd St. to check for the suspect. At the location, I observed a black female juvenile exit a silver BMW bearing Wisconsin registration plate #AYU-9489. The female identified herself as Jamariyana S. HICKS (B/F, 02-20-08). HICKS admitted to being involved in the fight at the location and striking MCKENZIE with a chair. HICKS was cited for battery and released.

During the investigation, the employees were cooperative and allowed access to the security cameras. All cameras were operational. All licenses were properly posted, visible and up to date.

Upon my arrival on scene, MFD Engine 21 (blue shift, Lt PICKETT) was already providing basic medical care for the overdose subject, who was in the front passenger seat of his 2008 Toyota Camry.

Witness stated that he was in Milwaukee from Michigan for a doctors appt. Witness stated that he and another subject had gone into Wendy's to get something to drink and left overdose subject in the front passenger seat of the vehicle. He was conscious and in okay condition. Witness stated that when they returned to the car, overdose subject was purple. Witness stated that he administered Narcan that he had in his car.

Overdose subject was provided medical care on scene by MFD and Bell Ambulance but refused transport and further medical care and was released.

No additional contact made with Wendy's staff.

This report is written by Police Officer (PO) Logan BURGE, assigned to District 5 Early Power shift, Squad 5532 with PO Shelley WEISSENBORN.

On Saturday, August 30th, 2025, at approximately 11:50AM I was dispatched to 633 W North Av, which is located in the City and County of Milwaukee for a subject with a weapon complaint.

Upon our arrival, I observed I observed the suspect, later identified as Colby M Q MITCHELL (b/m, 05/22/03) standing in the Wendy's near the south entrance. MITCHELL was given a lawful order to remain at the location which he disregarded and immediately exited through the south entrance of the Wendy's. Squad 5532 did not observe MITCHELL after exiting the Wendy's. A witness, later identified as Shaun K ANDRES (b/m, 09/10/90), stated he observed MITCHELL flee eastbound through an open lot. Squad 5532 attempted to locate MITCHELL and were unsuccessful.

I spoke to the license premise manager and caller/victim David J AKINES (b/m, 02/24/69), who was working at the location at the time of the incident. They stated MITCHELL had come through the drive thru two times to pick up a Door Dash order that was not yet ready. AKINES stated MITCHELL was instructed to park the car or come inside until his order was ready. AKINES stated MITCHELL became upset and accused AKINES of implying he is stupid. AKINES stated he calmly instructed MITCHELL to either park the vehicle or come inside to get his order. AKINES stated MITCHELL walked from the north entrance of the Wendy's to the south entrance of the Wendy's before entering and intentionally and without consent displayed a black Diamondback Firearms DB15 5.56 rifle bearing serial #DB2475571 which was concealed in his pants and revealed to the employees while stating, "wanna make something out of this?". AKINES stated MITCHELL's actions made him feel an imminent fear for his own safety and that of his employees. AKINES stated MITCHELL stayed in the lobby of the restaurant until police arrived.

#### Interview of Witness(GRIFFIN)

### Interview of Witness(THOMPSON)

I spoke with licensed premise worker Larissa A THOMPSON (b/f, 11-06-1975) who stated MITCHELL came through the drive thru two times. THOMPSON stated the second time MITCHELL came through the drive thru, he was told to either pull up on the side of the restaurant or come in to get the order. THOMPSON stated when MITCHELL entered the store, he was cussing out "Dave" (AKINES) and revealed the firearm to the staff. THOMPSON stated MITCHELL was mad due to the food not being ready.

The business was *cooperative* with the investigation. The business had zero security officers on scene.

I reviewed video surveillance footage. The surveillance footage depicts MITCHELL exiting his vehicle that was parked at the north entrance and walking around the exterior of the Wendy's to the south entrance. MITCHELL can be seen entering the Wendy's and walking to the counter. MITCHELL can be observed walking with a strange gait in his right leg. MITCHELL briefly walks away from the counter and when he turns back around, the butt end of a black rifle can be seen sticking out of MITCHELL's pants. MITCHELL walks towards the county and the Wendy's employees can be seen backing away towards the kitchen area. MITCHELL walks around the Wendy's until Squad 5532 arrives on scene, at which point MITCHELL quickly leaves out the south entrance to the store. The store staff helped get the footage quickly.

The weapon was recovered on scene after witnesses notified police it had been discarded.

Case pending, charges will be referred to DA's Office.
