This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 01/28/23 at 9:18pm, Milwaukee Police were dispatched to 818 W. Atkinson Av., for a trouble with subject complaint. Per the Computer Aided Dispatch system (C.A.D.) the caller stated two subject were pan handling outside causing a disturbance. Officers observed two subject walk away from the parking lot upon officer's arrival. Officers spoke with employee and looked over the business licenses which were not displayed due to the inside of the location being remolded.
- 2. On 04/10/23 at 12:15pm, Milwaukee Police were dispatched to 3279 N. 8th St., for a shooting complaint after the victim's roommate notified the police of the incident. The victim stated that she was shot in the morning hours between 5:00am to 6:00am, nearby at N 8th St and W Atkinson Av. Officers checked the surrounding area and located a single casing in the parking lot of the business at 818 W. Atkinson Av. Officers spoke with employee of the business who was cooperative with the investigation. Officers reviewed the business surveillance but could not observe the incident in the video footage. No calls were made by the business to report a shooting or shots fired incident.
- 3. On 06/27/23 at 11:14pm, Milwaukee Police were dispatched to 818 W. Atkinson Av., for a subject with gun complaint. Officers spoke with the caller who stated that she purchased a pizza from the gas station during the purchase the store clerk became hostile and brandished a hand gun. Officers noted that the caller appeared to be intoxicated, and was using profane

language, and making discriminatory remarks of Middle Eastern people. Officers spoke with the clerk who stated that the subject became upset and irate after he took her money. The clerk stated that the subject then began yelling racist remarks. The business was cooperative with police and provided video. After officers reviewed the video the officers found the complaint to be unfounded and baseless. The video showed the interaction between the caller and the store clerk. The video also did not show a hand gun being brandished. Officers did not locate a hand gun in the store. The caller was told to leave the property, by officers

- 4. On 11/10/24 at 8:35p.m., Milwaukee Police conducted a License Premise Check. No violations were found other than a few bags of expired chips on the shelf. The business was clean and cooperative.
- 5. On 02/12/25 at 10:14p.m., Milwaukee Police were dispatched to a Subject with Weapon. The business was the caller and stated a subject in the store had a gun and was trying to rob them. On officer's arrival the subject was taken into custody and charged with Disorderly Conduct While Armed. The gun was determined to be Airsoft.
- 6. On 04/26/25 at 12:07a.m., Milwaukee Police were dispatched to a Robbery. The officers were advised by the caller they were robbed at gunpoint of personal belongings and their vehicle. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

This report was written by Police Officer Kimberly L PETTERSEN, assigned to District 5, Late Power Shift (Squad 5468).

On Sunday, November 10th, 2024, at approximately 8:35 PM, my assigned partner PO Shelisa CARSON and I, conducted a license premise check at the address of 818 W, Atkinson Avenue., which is located in the City and County of Milwaukee (WI). This address is a gas station by the name of CITGO.

Upon our arrival, PO CARSON and I met with an employee, who was identified as Kabal SINGH (W/M 07-25-93). I advised K. SINGH that PO CARSON and I were at the location to check all of the issued permits for this business and to make sure all permits were up to date. I also advised SINGH that PO CARSON and I would be checking various items on the shelves to make sure there were no expired items, K. SINGH was very cooperative with PO CARSON and I. K. SINGH contacted the listed agent, Benipal S SINGH (W/M 12-28-79), while we were on the premises. I briefly spoke with B. SINGH over the phone and advised him that PO CARSON and I were just making sure all permits were up to date and that we would be checking items on the shelves to make sure there were no expired items. B. SINGH advised me that employees check the items on the shelves weekly to make sure there are no expired items. While speaking with B. SINGH, B. SINGH was also cooperative with PO CARSON and I.

I observed multiple permits located on a door that was behind the counter, where the employees are. I observed the following permits:

- Cigarette and Tobacco: Effective date of 12/13/2023 and an expiration date of 12/12/2024
- Food Dealer Retail: Effective date of 12/13/2023 and an expiration date of 12/12/2024

B. SINGH informed me that he recently applied for renewals on the above permits, since all will be expiring within the month of December. I conducted a search on the City of Milwaukee License Search and all of the above permits were listed as active, with renewals pending. The only permit that was not posted online was the Underground Storage Tank Permit, but was up to date on the posting on the door.

I observed a Certificate of Occupancy posted on the door that was issued on 8/31/2022.

I observed a Wisconsin Business Tax Registration Certificate posted on the door with an expiration date of 04/30/2026.

I observed a Certificate of Training issued to B. SENIPAL for Wisconsin UST Class A/B Operator Training that was issued on 11/17/2021.

I observed a form regarding Class C Underground Storage Tank Operator Site Specific Instructions, with emergency response contacts listed.

Some of the permits had the listed business hours posted on them which are the following:

I verified the hours of operation with B. SINGH and he informed me that the hours posted on the permits are correct.

I asked B. SINGH how many employees are employed at this business and B. SINGH stated that there are three employees. B. SINGH stated that one employee works day-time hours and one employee works night-time hours. B. SINGH stated that when this business is busy, he will have an additional employee come and help.

I asked K. SINGH what hours he works and K. SINGH stated that he works 8:00 PM to 8:00 AM.

I asked B. SINGH if he had surveillance cameras at his business and B. SINGH stated yes. B. SINGH stated that he has surveillance cameras on the exterior of the business, as well as inside. I asked B. SINGH if the surveillance cameras have 24 hour access and B. SINGH informed me that they did. B. SINGH stated that there is a password posted inside near the security monitor. B. SINGH stated that if the password can not be located, he accepts phone calls 24/7.

I asked B. SINGH if he has security working at his business and B. SINGH stated that he does not.

PO CARSON and I checked various items on the shelves and I was able to locate expired bags of chips,

approximately 7 bags that were expired in September of 2024. I informed K. SINGH that these items could not be on the shelves for purchase. Other than that, all items checked were not expired and good for purchase. I also did notice that there were items close to expiration dates and advised K. SINGH to just make sure these items are being checked on a weekly basis. Overall, this business was very clean and organized.

I informed B. SINGH that I would leave a Community Contact Card with K. SINGH.

The caller reported a subject was in the store with a gun and trying to rob him. The caller also stated the subject was banging on the security door and loading the firearm.

Squad 5438 arrived on scene and got the subject at gun point and he was taken into custody. Upon the completion of the investigation, the subject was charged with Disorderly Conduct while Armed and Violation of Probation.

Total number of squads- 5438- 2 Man 5468- 2 Man 5411- Sgt for the use of force.

The video surveillance showed the whole incident. The suspect walking around with a firearm (turned out to be an airsoft gun) and causing a disturbance in the store.

Squad 5438 conducted the criminal investigation.



Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
