Program Activity:

1. Organize neighborhood residents in neighborhood clean up efforts as identified and coordinated by the Department of Neighborhood Services.
2. Collaborate with Alderpersons and the Mayor's staff in a coordinated effort to increase community involvement in identified neighborhood improvement initiatives.
3. Coordinate meetings between neighborhood residents and CDBG-funded service providers, including follow up.
4. Door-to-door outreach, establish new block clubs, maintain existing block clubs, and maintain a community hot spot telephone line.
