APPEAL DECISION AGAINST THE CITY - LETTER DATED NOVEMBER 16, 2005

I sustained damage on October 5, 2005 when police made forced entry into my property on 5143 N. 41st Street in Milwaukee. I am requesting a hearing because the forced entry was negligent in this matter by the City, the on-duty supervisor admitted that the officers were negligent and stated the door would be replaced by the City.

As my boyfriend started to open the door which has plain glass at the top half of the door; the policemen saw him and they aggressively begin to **"kick in the door"**. After observing the behavior of the police officers they were asked to come to the front door of the house because the door was jammed shut. The police officers could have handled this situation more tactful than just **"kicking in the door"**. The on-duty supervisor gave me a claim against city damages yellow card after investigating the extremely damaged door. Again, he stated, "that my door would be replaced".

To date, my door has not been replaced. I am requesting that the City pay for damages to my property in the amount of \$1,075.90. This claim is "almost comparable" to the original solid wood maple door that was damaged by the City. The winter air coming through the damaged door is eventually going to affect my heating expense. Please respond to this matter as soon as possible. Thanks in advance for a timely response.

DESCRIPTION OF THE INCIDENT:

The Milwaukee Police Department (MPD) responded to a call at 5143 N. 41st Street in Milwaukee because my boyfriend and I were in disagreement. We resolved the issue before they arrived nevertheless, failed to call the MPD back to state their assistance was no longer needed.

We were on the second floor sleeping in bed and heard extremely loud kicking, bumping and knocking noises at the door of the side entrance of the house which caused the house alarm to sound off. My boyfriend immediately, came downstairs to cut off the alarm and to answer the side door. As my boyfriend started to open the door which has plain glass at the top half of the door; he saw the two police officers begin to **"kick in the door"**. The entire door was damaged including (2) dead bolt locks, the frame of the door, weather stripping was pushed away from the door and wood was broken and chipped away from the inside frame of the door. My boyfriend could not open the door because the police officers **"jammed the door shut"**. After observing, their behavior and the door they were asked to come to the front door of the house.

The Supervisor admitted to the damage of the entire door and stated that the door would be replaced by the City. He gave us a "CLAIM AGAINST CITY DAMAGES" yellow card and explained the filing claim against the city process to us and his contact phone number. Therefore, I am requesting a cash payment of \$1,075.90 for the cost of the door, (2) dead bolt locks, frame of the door, weather stripping around the door & frame; and installation of the door.

Note that there are (2) itemized estimates attached (**comparable to original door**) for the cost of damages at 5143 N. 41st Street in Milwaukee nevertheless, Home Depot is the only itemized estimate that install doors, between the (2) estimates. **Therefore, I will be purchasing at Home Depot. Menards does not install doors.** Therefore, I am requesting a cash payment of \$1,075.90 for damages. The outside flow of air is coming through the door and other damaged areas which will increase my heating expense. I would really appreciate a quick response to this request. 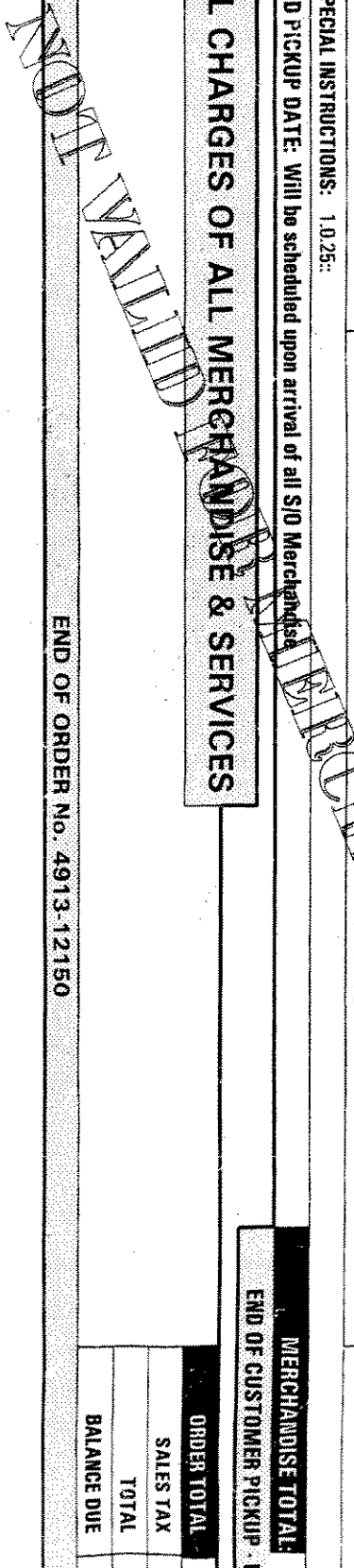

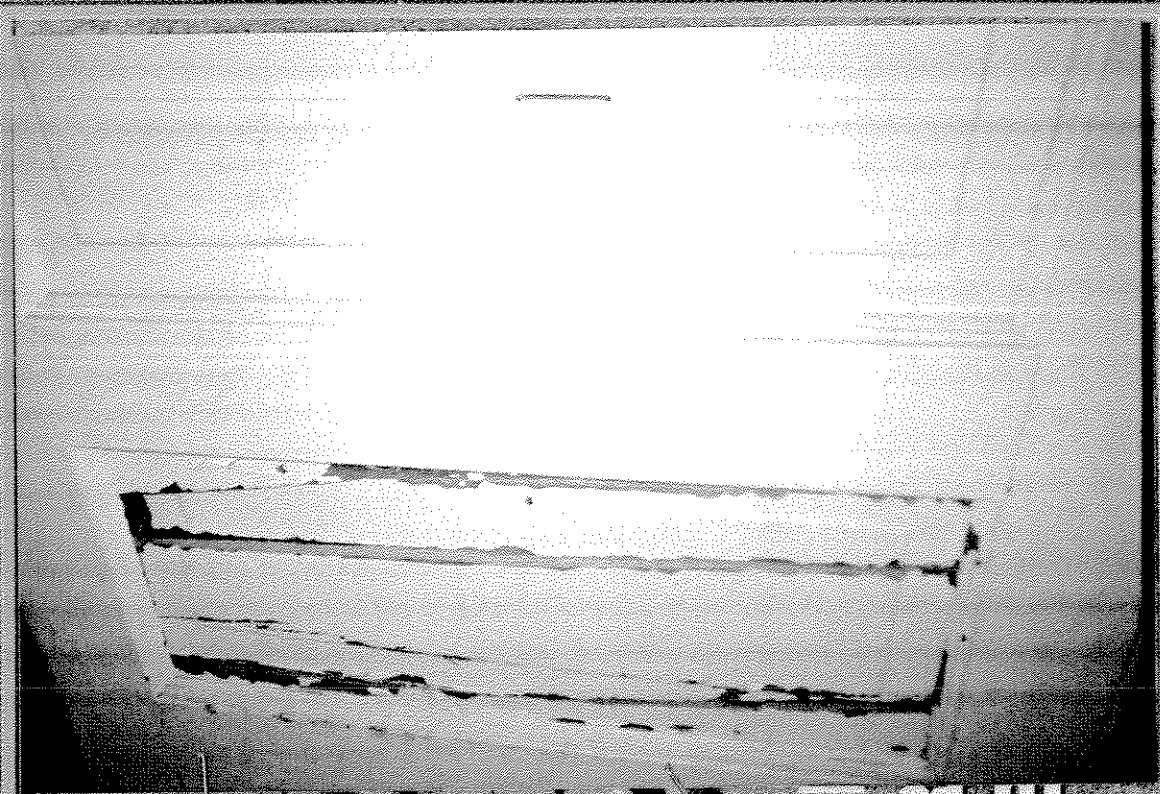
