
Dear Mr. Hinton, Mr. Arena, Ms. Caban-Rodriguez, Ms. Lee, Ms. Medina, Ms. Treinen and Mr. Hense:

You are hereby notified that the Milwaukee Common Council will hold a hearing on February 5, 2008, commencing at 9:00 a.m., or as soon thereafter as this matter may be heard, in the Common Council chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin to consider the Class "B" Tavern license revocation for the premises located 2525 North Holton Street ("Montal's Lounge").

Attached you will find a copy of the Report of the Licenses Committee which includes its Findings of Fact, Conclusions of Law and Recommendation, recommending revocation of the Class "B" Tavern license based upon complaints filed in this matter. The recommendation is the result of a public hearing before the Committee held on January 22, 2008 and complaints filed by Juana Caban-Rodriguez, America Medina, Mary Lee, Denise A. Treinen and James R. Hense.

You may file a written objection to the report of the Licenses Committee. If you file a written objection to the report, you may also appear before the Milwaukee Common Council to make oral arguments supporting your written objections and present oral arguments supporting that objection to the Common Council. Any written objections to the Committee's Report must be filed with the City Clerk by 4:45 p.m. on January 31, 2008. You or a legal representative may then also appear at the Common Council meeting and request an opportunity to address the Common Council for approximately five (5) minutes to present an oral argument on your own behalf.
