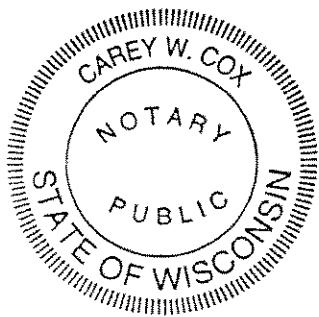

040473...Substitute ordinance to further amend the 2004 offices and positions in the City Service under control of the Common Council (Department of City Development, Health Department and Police Department).

040577...Substitute ordinance approving the change in zoning from Two-Family Residential (RT4) to Local Business (LB2), on land located on the East Side of North 6th Street and North of West North Avenue, in the 6th Aldermanic District.

040671...Substitute ordinance to further amend the 2004 rates of pay of offices and positions in the City Service under control of the Common Council (District Council #48, Association of Scientific Personnel & TEAM).

040673...A substitute ordinance relating to parking controls in various Aldermanic Districts.

040674...A substitute ordinance relating to traffic controls in various Aldermanic Districts.

040713...Substitute ordinance approving the change in zoning from a General Planned Development (GPD) to a Detailed Planned Development (DPD) known as Palermo's Pizza, located on the North Side of West Maple Street between South 8th and South 9th Streets, in the 12th Aldermanic District.

040714...Substitute ordinance approving the change in zoning from Two-Family Residential (RT4) and Local Business (LB2) to a General Planned Development (GPD) known as Palermo's Pizza, located on the North Side of West Maple Street between South 8th and South 9th Streets, in the 12th Aldermanic District.

040716...Substitute ordinance approving the change in zoning from Multi-Family Residential (RM2) to Multi-Family Residential (RM4), on land located on the East Side of South 3rd Street between West Pierce Street and West Bruce Street, in the 12th Aldermanic District.

040851...Ordinance relating to the change in zoning from Institutional (I1) to Local Business (LB1), on land located on the East Side of South Howell Avenue and North of East Layton Avenue, in the 13th Aldermanic District. (DCD)

040912...An ordinance relating to the period of the ambulance service plan for the citywide emergency medical service system commencing January 1, 2005.

040973...An ordinance relating to review of applications for public dance hall licenses by the commissioner of health.

040978...An ordinance relating to the composition and operation of the board of review.

040987...A substitute charter ordinance relating to retirement benefits for employees represented by certain bargaining units.
