Your Class B Tavern, Public Entertainment Premises and Food Dealer Licenses Application Requesting Instrumental Musicians and Disc Jockey as agent for "STONE LEGACY CORDATION" for "AYA" at 700 E KILBOURN Av #100.

There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-2.7-4, probative evidence concerning whether or not a new license should be granted may be presented on the following subjects: whether or not the applicant meets the municipal requirements, the appropriateness of the location and premises where the licensed premises is to be located and whether use of the premises for the purposes or activities permitted by the license would tend to facilitate a public or private nuisance or create undesirable neighborhood problems such as disorderly patrons, unreasonably loud noise, litter, and excessive traffic and parking congestion. Probative evidence relating to these matters may be taken from the plan of operation submitted with the license application, if any, but shall not include the content of any music. Evidence regarding the fitness of the location of the premises to be maintained as the principal place of business, including but not limited to whether there is an overconcentration of businesses of the type for which the license is sought; whether the proposal is consistent with any pertinent neighborhood business or development plans, or the location's proximity to areas where children are typically present. The applicant's record in operating similarly licensed premises; and whether or not the applicant has been charged with or convicted of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the activity to be permitted by the license being applied for or any other factor which reasonably relates to the public health, safety or welfare may also be considered. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Limited parking for persons attending meetings in City Hall is available at reduced rates (5 hour limit) at the Milwaukee Center on the southwest corner of East Kilbourn and North Water Street. Parking tickets must be validated in the first floor information booth in City Hall.

Dear City Clerk-License Division,

My name is and I have lived at for the past six years. I am a resident of this neighborhood who relies on city street parking, for which I pay the City, and I am writing to formally object to the proposed Class B Tavern, Public Entertainment Premises, and Food Dealer—Restaurant license application for AYA Restaurant at 700 E Kilbourn Ave #100 (Ascent Building).

Over the past several years, my ability to park near my home has been significantly impacted by major construction projects in the area, including the Northwestern Mutual building and, more recently, the Ascent building itself. Parking has already become scarce, and I am concerned that adding a new restaurant and public entertainment premises to this location will make the situation untenable for residents.

One major concern is the congestion caused by delivery drivers who already cluster around the Ascent building. This creates additional traffic and competition for the few available parking spots in the neighborhood. On top of that, while Ascent residents are offered underground parking within their building, many still choose to park on the street, further limiting the spaces available for neighbors like myself who do not have the option of secured parking.

As someone who works odd hours Wednesday through Sunday, I often return home late at night. Even under current conditions, it can be extremely difficult to find a parking spot. If this restaurant is approved without a requirement to provide its own dedicated parking solution, residents like myself will face an even greater struggle. The situation will unfairly prioritize short-term visitors to the restaurant over long-term residents who live, work, and pay to be here year-round.

For these reasons, I believe granting this license would negatively impact the welfare, quality of life, and livability of the neighborhood. Unless the applicant can demonstrate a concrete plan for addressing parking and traffic congestion, this proposal will create significant hardships for existing residents.

Comments/ Recommendations:						

This business is hosed in the lower south west corner of the Ascent apartment Building. During the inspection the business was under rough construction. The agent was on scene and explained her plans of operation.

The Ascent has an on-scene concierge 24 hours a day monitoring 16 exterior cameras.

Plans are to construct a vestibule at the front door that will have a host stationed there. A second area will be constructed near the front door for private parties. A bar will face the front door with seating along the bar and table seating within the rest of the space. No one under the age of 18 years of age will be allowed to sit at the bar without an adult.

At the rear of the space a door will exit into a common hall which will be equipped with 3 restrooms, an emergence exit door, an area used for storage until leased to second occupant. At the end of the hall a door equipped with a fob connects to the residential area and will only be used by the agent and Ascent's security. The business office will be at the end of the hall, with a locking door, interior and exterior camera monitoring. Additional cameras will be affixed in the interior of the business and hall area.

Plans are to be open by January 1st, 2026.




City Concentration Map 700 E KILBOURN AV #100






