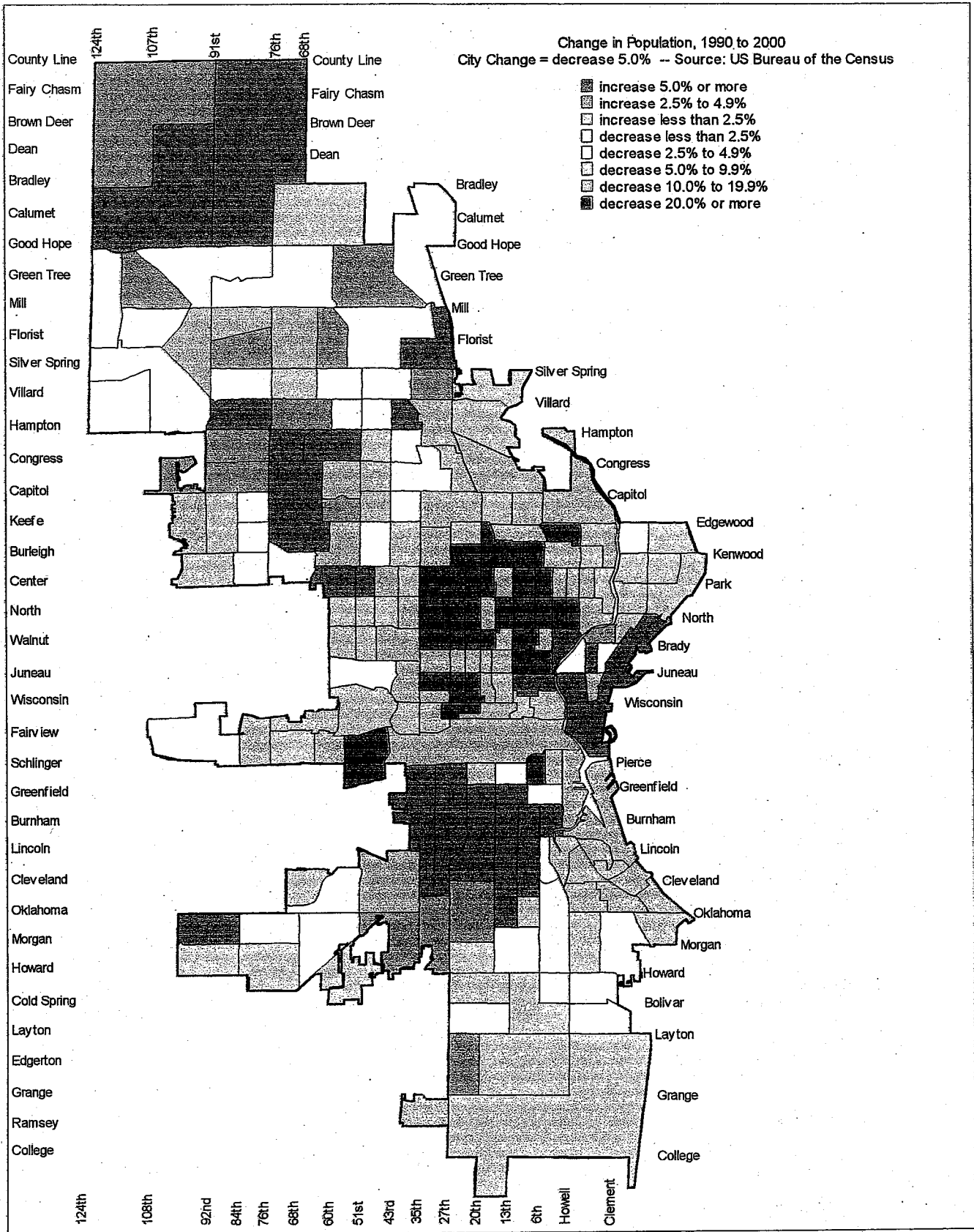
City of Milwaukee Population 1990 vs. 2000

Redistricting Procedures

- *County -- max. 60 days commencing April 2 to adopt tentative supervisory district plan*
- *City -- max. 60 days after receiving County tentative plan to adjust election ward boundaries*
- *City -- max. 60 days after adjusting ward boundaries to adopt aldermanic district plan*

Common Council Action Dates

- Judiciary & Legislation Committee *public hearings* for citizen input: June 2001
- Adjustment of *election wards*:
Committee action: July 30
Council action: August 2
- Adoption of *aldermanic districts*:
Committee action: October 8
Council action: October 12

Determining the Number of Aldermanic Districts

A 2/3 vote (12 out of 17 members) of the Common Council is required to change the number of aldermanic districts

Population Scenarios for Number of Aldermanic Districts

- *Population of aldermanic districts under various scenarios, based on city population of 596,974.*

17 districts -- 35,116
16 districts -- 37,311
15 districts -- 39,798
