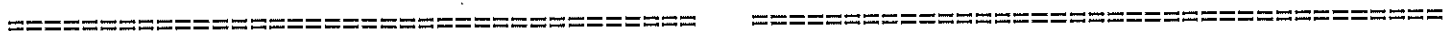
The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/18/16, applicant was cited for Building Code Violations at 2424 N Fratney Street.

2. On 06/26/16, Milwaukee police were dispatched to a 4th Degree Sexual Assault complaint at District #6 front desk. Investigation found the incident took place between 06/18/16 11:00 pm and 06/19/16 5:00 am at the Milwaukee Airport Inn at 1716 W Layton Avenue. The victim, who is an employee of the motel, stated a co-worker touched her body approximately 10 times during her shift at the front desk while she worked. The victim stated 5 out of 10 times the suspect intentionally and without consent, touched her vagina on the outside of her clothes. The owner of the motel, Prabhu Kasthurirangaian, cooperated with the investigation and made a copy of the security footage of the listed dates and information regarding the suspect. The case was no processed at the DA's office due to lack of evidence.
3. On 10/18/16 at 9:02 pm, Milwaukee police were dispatched to 1716 W Layton Avenue for an armed robbery complaint. Officers spoke with an employee of the motel who stated an unknown male subject handed her a note and demanded money from the cash register and

implied he had a weapon. The owner, Prabhu Kasthurirangaian, was notified of the robbery. Police were able to view surveillance of the incident.



4. On 08/30/19 at 10:52pm, Milwaukee Police were dispatched to 1716 W. Layton Avenue (Room 146) for a fight complaint. Officer's interviewed an injured citizen who stated that he did not get into a physical altercation but "fell" in the hallway. A person in a neighboring room stated that the injured subject was in a physical fight with two unknown actors. While interviewing the suspected victim, officers observed that the sliding glass door to room 146 had a large piece of plywood on it and had exposed glass facing the exterior of the room. The clerk at the hotel said the glass had been broken for about a month and does not know when it will be repaired. A check of the "calls for service" showed that multiple calls regarding the tenants in rooms 146 and 148 because they often "fight" each other.
5. On 09/22/19 at 11:26pm, Milwaukee Police were dispatched to 1716 W. Layton Avenue (Room 127) for a property damage complaint. Investigation revealed that an ex-boyfriend broke into room 127 through the patio window. The tenant in the room called the front desk who, in turn called the police. Police found the subject in room 146, told him he was not allowed at the hotel, and escorted him off the property. While police were still on scene, the subject returned to the location twice and was subsequently arrested. The manager worked well with officers and was able to provide them with information to help locate and identify the suspect.
6. On 10/18/19 at 8:30am, Milwaukee Police were dispatched to 1716 W. Layton Avenue for an armed robbery complaint. Investigation revealed that the alleged victim met a subject at the hotel for the purpose of prostitution. The manager was informed of the situation and he stated that he would not rent any more rooms to the subject.
7. On 10/18/19 at 11:27pm, Milwaukee Police conducted an underage alcohol procurement at the address of 1716 W. Layton Avenue. During the "sting" and underage Police Aide was able to buy a bottle of beer from the bartender inside the tavern at that location. The bartender, Chansamay BOUNKET was cited.

8. On 11/02/19 at 1:37am, Milwaukee Police were dispatched to 1716 W. Layton Avenue for a threat complaint. Upon arrival, officers interviewed the caller who stated that he was assaulted by two males who told him that he was stalking the bartender inside the tavern of the establishment. Officers interviewed the bartender who stated that the caller frequents the tavern while she is working and tonight, he was parked in his vehicle, with his high beams shining through the window, staring at her. The bartender says that she told other patrons inside the tavern that she does not feel comfortable when the caller is around but denies that she told the two males to confront the caller. The caller was told that he was not welcome at the tavern, so he checked into the hotel for the next two days.

9. On 03/18/20 at 08:26pm, Milwaukee Police conducted a license premise check at 1716 W. Layton Avenue to see if the tavern at the establishment was in compliance with Emergency Order #5 (inside Executive Order #72). Upon entering the tavern, officers observed two patrons sitting at the bar and one of the subjects had a drink. Officers informed the bartender that per the Governor, people were not allowed to be inside any establishment that serves food or drink. The bartender was under the impression that people could have a drink at the bar when they were waiting for their food. The officers went over Executive Order #72 (Emergency Order #5) and the bartender understood the order and made sure they are immediately followed by asking both patrons to leave. The bartender was extremely cooperative in the past and was again during this encounter. The bartender was given a copy of Emergency Order #5 and the premise check was ended.

This report was written by P.O. Shawn SWITZER, assigned to District Six, Late Power Shift, Squad 6468.

On Friday, August 30, 2019 at approximately 10:52 pm P.O. Christopher JACKSON and I were dispatched to 1716 W Layton Av ROOM 146 (Travellodge by Wyndham) for a battery call for service.

Upon arrival, we spoke with P.O. Eric LAUX and P.O. Joseph ZINGSHEIM, Squad 6231. Who informed us that the victim Timothy M CHOJNACKI (m/w 03-23-83) stated he fell in the hallway and did not get into a fight. They stated that CHOJNACKI had a laceration on the left side of his head and declined medical treatment. A neighbor stated that CHOJNACKI was in a fight with two unknown actors. I observed that the large sliding glass door to room 146 was covered with a large piece of plywood and exposed glass could be seen on the exterior of the room. The clerk at the front counter, Yvonne M RODRIGUEZ (w/f 10-04-90) stated the glass has been broken for approximately a month and she does not know if there is a plan to repair it.

A check of the call history at 1716 W Layton Av revealed that in the month of August, 2019 there have been multiple calls for service regarding room 146 and room 148. RODRIGUEZ stated the residents in rooms 146 and 148 often fight with each other and have been given several warnings. RODRIGUEZ stated they will be kicked out of the hotel following the incident on August 30, 2019.

This report is being written by P.O. Christopher JACKSON assigned to District Six, Late Power Shift.

It should be noted that during my tour of duty I was in full duty uniform with an axon body camera affixed with a headband. Also driving and operating a marked police squad with MVDR ability.

On Sunday, September 22, 2019 I was assigned to the License Premise Unit, Squad 6468 along with P.O. Shawn SWITZER. At approximately 11:26pm we were dispatched a Property Damage service call at 1716 W. Layton Av. #127 in the City and County of Milwaukee.

Upon arrival to the location we spoke with Cory N. CRAWFORD (F/B 08-03-95). CRAWFORD stated that at approximately 11:30pm her ex-boyfriend later identified as Detrick Q. CHILDRESS (M/B 10-14-91) came to her hotel room#127. He was outside of the room and trying to gain access to her room. She continued to refuse to let him in and then he broke through the patio window. CRAWFORD notified the manager Robert P. JAMES (M/B 03-18-63) and police were called.

JAMES stated that he wanted CHILDRESS issued a citation for the property, wanted him removed and informed he was not allowed on the premises. CHILDRESS was located in room#146, walked off the premises, informed he was not allowed back and a citation would be mailed to his address. While we were still on scene CHILDRESS returned back to the location twice and JAMES requested that he be issued a Trespassing citation for returning. CHILDRESS was taken into custody and conveyed to District Six regarding.

While at the District station I contacted Community Corrections regarding CHILDRESS' probation status and the above incidents. A hold was placed on CHILDRESS through that department. The citation court dates were posted for 09/24/19 at 8:30am.

It should be noted that JAMES worked well with officers as we investigated this incident. he was able to provide us information that was used to locate and identify CHILDRESS.

On Friday 10/18/2019 at 8:30 A.M., Sq 6134 responded to the Travelodge located at 1716 W Layton AV for an Armed Robbery complaint.

Upon arrival, I spoke to the complainant, Timothy T NABORS (b/m 03/11/1977), who stated that he rented a room with a Hispanic female, known only to him as Marie. NABORS stated that they spent the night together and in the morning, she left, stealing \$750 in cash and 2 bottles of his Oxycodone. After further investigation, it was determined that the theft was baseless and that NABORS met 'Marie' at the hotel for the purpose of prostitution. NABORS states that he has met women a few times at this hotel to 'hook up', but denies it was prostitution. NABORS deleted all the text messages between himself and MARIE prior to our investigation, stating it was an accident.

I spoke to the manager, James R PERRY (b/m 03/18/1963) and informed him of the incident and the suspected prostitution, he stated that he would not rent rooms to NABORS in the future. I informed PERRY of my intention to write a License Premise report regarding this incident.

This report was written by P.O. Shawn SWITZER, assigned to District Six, Late Power Shift, Squad 6468.

On Friday, October 18, 2019 District Six Power Shift Squads 6468, 6467 and 6411 initiated an underage compliance check. During the checks, one plain clothed Police officer (P.O.) and one plain clothed Police Aide (P.A.) attempted to enter several taverns throughout District Six. The Police Aide was under the age of 21.

Squad 6468. P.O. Shawn SWITZER and P.O. Christopher JACKSON.

Squad 6467. P.O. Paige CARLONI and P.A. Christopher ROMERO-SANCHEZ.

Squad 6411. Sgt. Cassandra BENITEZ

Both the Police Officer and the Police Aide were given instructions prior to conducting the compliance checks. Plain clothed personnel were instructed not allowed to consume any alcoholic beverages. The plain clothed Police Officer was given discretion to provide their identification cards at the bar, the Police Aide was instructed to say they did not have any identification when asked and to state their true age. The Police Officer was instructed to not purchase anything at the bar, the Police Aide was instructed to purchase a bottle of Miller Lite or a similar bottle of beer. The police Officer took a photograph of the underage Police Aide while the Police Aide was holding the bottle of beer.

On Friday, October 19, 2019 P.A. Christopher ROMERO-SANCHEZ and P.O. Paige CARLONI entered MAI's Bar located at 1716 W Layton Av at approximately 11:27 pm. P.A. ROMERO-SANCHEZ, who is 20 years old, sat at the bar and ordered a Corona in a glass bottle from the bar tender Chanhsamay M BOUNKET (w/f 04-17-58). BOUNKET did not ask P.A. ROMERO-SANCHEZ for any identification to verify his age and did not ask his age. BOUNKET gave P.A. ROMERO-SANCHEZ a bottle of Corona and charged him \$5.00. P.O. CARLONI then took a photograph of P.A. ROMERO-SANCHEZ using a Department issued cellular phone inside while P.A. ROMERO-SANCHEZ was inside of the bar and in possession of the bottle of Corona. The images were placed on inventory (#19035275) The Phones serial number is 014391000473121.

At approximately 1:16 am P.O. JACKSON and I returned to 1716 W Layton Av (MAI's Bar) and spoke with BOUNKET regarding the investigation. BOUNKET stated she checked P.A. ROMERO-SANCHEZ's

This report is being written by P.O. Christopher JACKSON assigned to District Six, Late Power Shift.

It should be noted that during my tour of duty I was in full duty uniform with an axon body camera affixed with a headband. Also driving and operating a marked police squad with MDVR ability.

On Saturday, November 2, 2019 I was assigned to the License Premise Unit, Squad 6468 along with P.O. Shawn SWITZER. At approximately 1:37am we responded to a Threat complaint at (Travelodge/MIA's) located at 1716 W. Layton Av. in the City of Milwaukee.

Other responding Squads included:

- Squad 6420, P.O. Christopher MOORE and P.O. Frank HEEG
- Squad 6390, P.O. Daniel PARKS

Upon arrival to the location I spoke with the caller identified as Sulaiman A.S. ALMUTAIRI (M/W 06-27-96). ALMUTAIRI stated that he was sitting in his car minding his business when he was approached by two Hispanic males. He stated that the two subjects threatened to harm him and accused him of stalking his girlfriend who was the bartender at the bar. ALMUTAIRI then stated that he was engaged in a verbal argument with subjects over the allegations. The two subjects became physical and then assaulted him by punching and kicking him to the ground causing him pain and discomfort. The subjects fled the location before officers arrived to meet the caller. Squad 6420, P.O. MOORE and P.O. HEEG checked the area for the subjects and were unable to locate or identify them.

I spoke with Lizmarie RASARIO (F/W 04-24-95) who was the on duty bartender for the evening. RASARIO stated that she was working as the bartender and there were 2 Hispanic males that were drinking at the location. She further stated that the caller ALMUTAIRI does frequent the bar when she's working. She stated that ALMUTAIRI likes her, watches her from up close and from afar while making her feel uncomfortable. When ALMUTAIRI arrived he sat in his vehicle with the front end facing the bar and high beams glaring through the window. RASARIO stated that she mentioned that she didn't feel comfortable around ALMUTAIRI to all the occupants of the bar. The two subjects went to confront ALMUTAIRI but RASARIO stated she did not send them and that she did not know them besides being in the bar that day.

This assignment ended with the actors involved in the battery not being located. ALMUTAIRI

This report is written by P.O. Joel BUNKELMAN, assigned to District 6, Late Power shift, squad 6468.

On Wednesday, March 18th, 2020, P.O. Joshua YANG and I were assigned to the License Premise squad (squad 6468). We were instructed by SGT Bradley SCHLEI (squad 6411) to check on all the licensed bar and food establishments in District 6 to observe if they were in compliance with Governor EVERS' Executive Order #72, Emergency Order #5 dated March 17th, 2020.

We conducted a check at Mai's Sports Bar and Grill which is connected to the Spring Garden's Cafe. This establishment shares space with the Travel Lodge hotel. The address for this establishment is 1716 W Layton AV and is located in the city and county of Milwaukee. We entered the establishment through the east entrance that connects the bar to the hotel. The bar was playing music and there was two people sitting at the bar. There was a black male and black female sitting at the bar. The male had a mixed drink in front of him that he was stirring and the female did not have any beverage in front of her. There was a waitress behind the bar who greeted us when we entered the establishment. I asked who the bartender on duty was and she stated that she would get her.

A Few moments later we were greeted by the on duty bartender who was identified as Chanh samay M BOUNKET (a/f 4-17-58). I advised BOUNKET that the according to Emergency Order #5 no food or beverage may be consumed inside the restaurant. BOUNKET stated that she was under the impression that she could serve people drinks while they were waiting for their food. I advised her that according to Line 11 sub a. no seating may be provided and food may not be consumed. She understood the guidelines when I explained them to her.

BOUNKET immediately advised both patrons that they could not sit at the bar and the male was not allowed to consume his beverage. BOUNKET again apologized for her not understanding the emergency regulations and would make sure that they would be immediately followed.

BOUNKET has been extremely cooperative in the past and was again during this encounter. BOUNKET was given a copy of Emergency Order number #5 along with a PF-06. We asked if BOUNKET if she had any questions and she stated that she did not. We advised her that a License Premise report would be filed and she stated that she understood. She thanked us for advising her on the regulations and we left the establishment.


