Hi Chris,

Per your request, the following changes are requested to be made in the 2019 Positions Ordinance relative to adding 11 sergeant positions and decreasing 10 lieutenant positions:

Robbery Division: +3 Police Sergeant/ -3 Police Lieutenant
Violent Crimes Division: +5 Police Sergeant / -4 Police Lieutenant
Property Crimes: +3 Police Sergeant / -3 Police Lieutenant

Regarding Alderwoman Coggs' follow-up questions about the reasons for this request, please see the Department's official response:

The Chief, in his discretion as the Department head, is reorganizing the police department to better effectuate his crime prevention strategy. By adding 11 sergeants and removing 10 lieutenants, the Department will be gaining one additional supervisor while saving approximately \$14,000 in annual salaries. Sergeants serve as frontline supervisors and this particular reorganization will allow more field supervision for the detective bureau. In addition, there is currently an active sergeants list and no current lieutenant list. It is our understanding that the FPC will not be able to create a new list until the end of 2019; thus, this decision allows for necessary promotions to occur expeditiously, well in advance of next year's DNC.
