Dear Council Members:

We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.

Claimant, Mary Beth Doyle, 14925 Hushing Brae Court, Brookfield, WI 53005, alleges that on December 30, 2002 she sustained damages when a clogged sanitary sewer lateral backed-up into her property located at 4153 North 84th Street. She claims damages in the amount of \$5,210.00.

Our investigation reveals that the Infrastructure Services Division records indicate that this matter was reported to and investigated by them on December 30, 2002. The City main sewer was found to be in proper working condition. The sanitary lateral was determined to be the cause of the backwater. They recommended that it be cleaned by a plumber. Laterals are the responsibility of the property owner by Charter Ordinance. The Forestry Division records indicate that, after receipt of the claim, they investigated and found the tree in question to be alive, healthy and not causing above-ground structural problems. They searched their service request file for the last four years and
