Dear Council Members:


Common Council File No. 010359, Substitute 2, increases the fees for lead reduction permits, milk distributors licenses, re-inspection fees for health code violations, site evaluations for food operations, fees for weighing and measuring devices, vehicle tank and bulk plant meters, parking meter temporary removal or hooding, certificate of occupancy and zonings, fire inspections, flood plain location certificates, plan examination buildings, automatic sprinklers, heating and ventilating fees, plan examination extensions, plan examination petitions for state modifications, plan examination structural plans, variances for the state building code, and zoning statements.

This ordinance was transmitted to the City Attorney for approval as to legality and enforceability.

So long as the fees and increases in question do not exceed the actual and necessary costs of providing the service, merely recoup the expenses of providing the service, and do not generate revenue over and above such costs, the file is approved as to legality and enforceability.
