Dear Ms. Williams:

We have received your claim relating to the towing and damage sustained to your vehicle on January 15, 2005 when it was towed to the City of Milwaukee Tow Lot located at 3811 West Lincoln Avenue.

Our investigation reveals that your vehicle was towed on January 15, 2005 for being parked in Excess of 24 hours. The PT-27 form, completed prior to the tow, notes scratches and dents all around the vehicle. The damage to your vehicle appears to have happened prior to the tow. As such, the City cannot accept liability. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
