I feel the City's procedure was improper due to the following reasons and I have attached any supporting evidence, including city employee's names/dates which I spoke to regarding this issue and copies of any city orders received:
We have owned this property and have been in business here for 24 years.
In that time we have never had an issue with clearing our
Walkways in a timely manner, in fact we often help neighbors
with their walks as well. That said on 50% of our walks were
cleared including all 3 of our driveways and the enterance
to the ally behind our building. There was about 75 feet
of covered walkway along Appleton Ave including some areas

near the corner of the intersection by city plows. These piles quickly froze and were not able to be cleared without equipment. When I spoke to the guys who came here to clear the walks they said they were charging us for the entire walkway which is not what they did and not fair. There was a team of 3 guys and 2 of them stood around while one guy used the earlpment (mini skid steer) to clear the walks. It is not fair to be billed this amount for the Short amount of work that was done.
