Dear Mr. Harvieux:


We have received your claim in the amount of \$4,559.00, relating to damage sustained to your property on January 24, 2005 when it was allegedly flooded with water due to a water main break at 9323 West Lisbon Avenue.

Our investigation reveals the Milwaukee Water Works (MWW) control center was contacted by the Milwaukee Fire Department on the subject date at 10:00 p.m. regarding a suspected main break in the street at 9323 West Lisbon Avenue. A MWW Supervisor confirmed there was a break in an 8" water main at 10:28 p.m. and the main was turned off at 10:34 p.m. The MWW repaired the main and placed it back in service on January 25, 2005 at 3:56 a.m. The MWW responded to the water main in a timely manner and followed standard procedures regarding the repair activity, and as such, the City cannot accept liability. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
