I am filing a claim against the city of Milwaukee under Statute 893.80 involving the following circumstances.

I was arrested on 1/16/07 for a DUI by the Milwaukee Police Department but my case was later dismissed as my blood alcohol content was 0.0 meaning no alcohol in my bloodstream. But while I waited for my trial to finish concerning the aforementioned DUI a whole series of events seemingly conspired to cause me to lose my SUV, and also many items which were inside the SUV after I was wrongfully arrested for the DUI, resulting in my SUV being taken and towed by the ~~police~~ tow lot working with the Milwaukee Police Department.

The events are as follows:

- Wrongfully arrested by the police on 1/16/07 for DUI for which I was later acquitted.
- Having my SUV towed and taken from me because of the DUI charge which as mentioned before should never have happened but as a result of that charge the SUV was taken to a tow lot, while I was wrongfully imprisoned and it seemingly disappeared from there.
- I didn't have the money for bail to claim the SUV, but was told it would be held at the tow lot until after I was released from jail and could reclaim it at that time.
- After I was released I went to the tow lot and they said a towing company in town

picked up my SUV but the company had no knowledge of ever claiming it after I spoke with them.

— The police and generally the entire system while I was incarcerated were in general dismissive in their attitude towards any requests I made to contact help on the outside to reclaim my SUV before I would be released and any further description of their behavior towards me during that time can be provided if needed.

— All these events have resulted in me having no transportation at this time because of the arrest and acquittal which has caused more problems with finding a place to live and also transportation for either work or continuing on with school.

— One other circumstance which should be mentioned and probably would have helped to avoid the ticket being issued, is the fact that I offered to take a field sobriety test when I was arrested but the officers refused my request and issued the ticket, and took me to a hospital for a blood test with the resulting B.A.C. of 0.16.
