Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. 2. On 07/30/25, at 7:12 p.m., Milwaukee Police responded to a Shooting. The agent attempted to stop two subjects that stole cans of sodas. One subject produced a handgun and shot the agent.
3. On 12/03/25, at 7:46 p.m., Milwaukee Police received a Threat complaint. A customer in the store became angry after not understanding they were provided a refund receipt for items they purchased. No violations observed

This report is being written by PO Darion DZIATKIEWICZ, assigned to District 5, Late Shift.

On Thursday, July 10, 2025, at 2:11 PM, WHILE IN FULL DUTY UNIFORM EQUIPPED WITH AN AXON BODY WORN CAMERA ACTIVATED AND IN A MARKED SQUAD, my partner PO Joshua TRYAN-HERNANDEZ and I (Squad 5130) were dispatched to a Subject with Weapon complaint located at 1200 W Keefe Av (KRAZY NACHOS), which is located in the City and County of Milwaukee.

Upon arrival, I was met by the Victim/Business agent, identified as Bonnie K. FLORES (w/f, 08/24/1968), who stated she was assaulted by two females, stating they broke her wrist, as she showed me her wrist, that was apparently swollen and bruised. FLORES requested medical attention immediately.

I spoke to the caller/Business agent, Mohammed Q. JARABA (w/m, 05/29/1986, 414-335-1567) JARABA reported he was assisting FLORES prepare food orders, when a female in a white t-shirt entered the store. JARABA stated the female was on the phone, sounding like she was arguing with someone. JARABA stated she was angry while ordering. JARABA stated the female was angry and began yelling and cussing at FLORES because she wanted to get her food before going to the other counter to pay for it first. JARABA stated he told the female in the white t-shirt to leave, and FLORES walked her to the entrance. JARABA stated the female left the store appearing to have left but ran back in and charged at FLORES. JARABA stated the female in the white t-shirt appeared to have hit FLORES, and FLORES swung back. JARABA stated they began fighting, and the female in white threw FLORES to the ground multiple times. JARABA stated multiple others engaged in the altercation, including another black female in a

black t-shirt, and him in attempt to break up the fight.

I spoke to witnesses Rohidh NMI MAHAKALA (w/m, 02/23/2000) and Yahia NMI ISHAQ (w/m, 01/28/1976). Both stated that the description of events given by FLORES and JARABA were accurate and they had no other information to give.

The business was cooperative with the investigation due to allowing officers to view video footage of the incident. The business had 0 security officers on scene.

I reviewed video surveillance footage inside the premises, which JARABA provided. The footage showed Video had no sound, and the time stamp was an hour faster than the actual time. The video footage showed Suspect #1 enter the store, on the phone. Due to the video having no sound, I could not confirm what was said or if the female was yelling as she entered. Suspect #1 went to the front counter, appearing to order food. The female appeared to be agitated as she walked to the back counter where Bonnie and JARABA were. Suspect #1 appeared to be yelling at Bonnie and JARABA. Bonnie walked Suspect #1 to the front, and she exited. A few moments later, Suspect #1 ran back into the store towards Bonnie, motioning as if she was going to hit her. I cannot confirm whether Suspect #1 made contact. Bonnie swung and appeared to hit Suspect #1 in the face and neck area. Suspect #1 began hitting Bonnie repeatedly, Bonnie fell to the floor. Naomi, JARABA, and Suspect #2, all engaged. The group split, and Suspect #1 was taken out of the store, and eventually Suspect #2. Both suspects attempted to reenter the store at least two more times.

The video was recovered uploaded to Evidence.com.

While on scene, I observed the licenses posted and they were up to date. During my investigation for Subject with a Weapon, I did not observe any violations in the licensed premise.

On Wednesday, July 30th, 2025, I was dispatched to 1200 W Keefe Ave (Krazy Nachos) , which is located in the City and County of Milwaukee, to assist with Shooting.

Upon arrival, I observed several squads on scene already, as well as the Milwaukee Fire Department.

I made contact with Incident Commander Sergeant James Knapinski who delegated me with writing the Licensed Premise Report.

I entered the business and made contact with an employee who verbally identified herself as Bonnie K FLORES (w/b, 8-24-68). FLORES stated she is a cook at the business. FLORES stated she was working at the time of the shooting. FLORES stated she works 7 days a week form 8am-9pm.

I spoke to Mohammed Q JARABA (a/b, 5-29-86) who stated he was the owners "brother in law". JARABA stated he was not working at the time of the shooting and arrived shortly after.

The business had zero security officers on scene and never do.

Detectives arrived on scene to take over the investigation and were able to review surveillance, which captured the suspect(s) inside the store.

While on scene, I observed the licenses posted and they were up to date.

JARABA and FLORES were both extremely cooperative during the investigation.

This concludes my portion of the investigation.

On Wednesday July 30th, 2025, at approximately 7:10PM the victim, Yahia ISHAQ (W/M 1-28-76), stated he was shot outside of his store, located at 1200 W Keefe Av. (Krazy Nachos). ISHAQ stated two suspects walked inside the store asked for water and he told them no. The two subjects took 2 sodas from the store and walked out. ISHAQ ran out the store to confront them about stealing the soda. ISHAQ stated one of the suspects, B/M unknown clothing 16-17 yoa, pulled out a firearm and shot him.

ISHAQ had one (1) GSW to the upper left thigh area.

1 casing was recovered at the location of 1134 W Keefe Av.

Witness on scene stated suspects was wearing all black second suspect unknown clothing.

MFD arrived on scene and transported ISHAQ to Froedtert hospital.

Video footage captured the suspects inside the store but did not capture the shooting outside of the store due to there being no cameras outside the store.

You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
