Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 05/03/23 at 4:09p.m., Milwaukee Police were dispatched to a Theft at 5401 N. Lovers Lane Rd. Investigation revealed an employee that had recently been terminated had taken cash and lottery tickets from their employer. The agent was cooperative and provided the officer with video surveillance of the incident, however later contacted the officer to state they no longer wished to be a complainant.
- 2. On 06/27/23 at 1:51a.m., Milwaukee Police were dispatched to a Property Damage at 5401 N. Lovers Lane Rd. Investigation revealed two minor customers entered and attempted to purchase tobacco products, however when the sale was refused due to their age, they threw a brick through the agent's car window, causing damage. The agent was cooperative and allowed officers to view video surveillance of the incident.

3. On 09/24/23 at 11:45a.m., Milwaukee Police were dispatched to a Trouble with Subject at 5401 N Lovers Lane. Officers were advised a subject refused to leave after being told they could not purchase tobacco due to not providing an ID. Once officers were called the subject left the store.

4. On 01/31/24 at 12:30p.m., Milwaukee Police were dispatched to a Hold Up Alarm at 54001 N. Lovers Lane. Investigation revealed it was a false alarm.

5. On 06/25/24 at 10:25pm, Milwaukee Police were dispatched to 5401 N. Lovers Lane Road for an armed robbery compliant. Investigation revealed that the victim drove into the filling station to pump fuel into his vehicle and was approached by the suspect, who had a firearm, and he took the victims vehicle. The employee was unaware of the incident was able to provide video surveillance.

6. On 11/11/24 at 10:38am, Milwaukee Police were dispatched to 5401 N. Lovers Lane Road for a trouble with subject compliant. Investigation revealed that on 11/08/24 an employee sold a vape cartridge to an underage person and their mother was inside the establishment wanting to press charges. The employee admitted to selling the cartridge to the underage person and the applicant was notified. The applicant, who was cooperative, retrieved video of the incident for the officers. The employee was issued a citation for Sale of Cigarettes to Minor/Underage.

On Tuesday, June 25th, 2024, at approximately 10:25PM, while in full duty uniform equipped with an Axon body worn camera activated and in a marked squad, PO Suzana DIMITIRJEVIC and I were dispatched to an armed robbery that occurred at the location of 5401 N. Lovers Lane Rd.

PO DIMITRIJEVIC and I were able to speak to the victim: Micah L. MOORE (B/M 05/2/1986), who stated that he pulled into the gas station at the above listed location and attempted to pump his Gray, 4DR, 2012 Audi A7, bearing 2, WI Reg. plates AEH-6173, when he was approached by an unknown B/M asking for a lighter, at which point the unknown male robbed MOORE at gun point for the above listed vehicle.

PO DAUGHTY and PO STEGERWALD responded to the location 5401 N Lovers Lane RD to check for video.

PO STEGERWALD and PO DAUGHTY would make contact with the gas station clerk and advised him of the incident, in which he was unaware of the incident and then allowed them to review video.

Video was recovered and would be uploaded to evidence.com, showing the armed robbery in question at the above listed location near pump #2

While on scene, I observed the licenses posted and they were up to date

Per the district community partnership unit this location is not a designated nuisance premise.

This report is written by PO Da'Shaun PERRY, assigned to District Four, Day shift, Squad 4134 with PO Benjamin SPITZER. Both officers were equipped with Axon body worn cameras which were activated during the course of this investigation.

On Monday, November 11th, 2024, at 10:38 AM, we were dispatched to 5401 N. Lovers Lane Rd, Lovers Lane Mart Gas Station, which is located within the City and County of Milwaukee, WI., for a trouble with subject complaint.

On 11/11/2024, at 08:17 AM the caller, identified as Reason A. HILL (B/F 08/12/1987), called reporting that an employee, later identified as Dianguiana TOURE (B/M 08-09-1969), of the dispatched gas station sold her son, identified as Te' ryji R. RILEY (B/M 03-06-2010), who is under the age of 18, a nicotine vape pen on 11-08-2024.

We made contact with HILL at the gas station who stated that on 11-08-2024 her son bought a vape cartridge from the dispatched gas station which made her son sick. HILL stated that she came to the location to confront the employee about selling her son a vape cartridge, to which the employee admitted to selling to her son. HILL stated that she recorded the incident on her cellphone and that she would want to press charges against the employee. I viewed the video to which the employee apologized to selling the vape cartage to RILEY. I sent HILL an Axon request to upload this evidence.

PO SPITZER made contact with the owner of the gas station, identified as Ram N. POKHREL (I/M 11-17-1970), who stated that on 11-08-2024, that TOURE called him and admitted to selling the nicotine vape to the minor on accident. POKHREL called TOURE who spoke with PO SPITZER over the phone. TPURE stated that he did sell the nicotine vape to the minor on accident and he did not know exactly what time the incident occurred. TOURE was advised that he would be receiving a citation and that it would be left with POKHREL.

POKHREL was cooperative with our investigation and allowed us access to the cameras. We watched the video on 11-08-24 from 4:00 PM to 08:00 PM and were not able to locate RILEY on video purchasing the vape, but we did locate HILL confronting TOURE regarding this incident at approximately 08:00 PM. PO SPITZER recorded the video with his body worn camera.

On Sunday, May 04, 2025, at 1:20 PM, I was dispatched to 5401 N. LOVERS LANE RD for a Theft Complaint.

Upon our arrival I observed the gas station to be operating under its normal business hours, clean on the interior no signs of disarray.

I spoke to the caller, *identified via WI. Drivers License as Ram N POKHREL (A/M, 11/17/70)* They stated at approximately 11:54AM seven (7) unknown subjects entered the business, and took multiple "grocery" items past the last point of sale without rendering payment, permanently depriving the business of their property.

The business was cooperative with the investigation. The business had 0 security officers on scene.

I reviewed video surveillance footage. The footage showed the system was approximately 1 hour behind the current time. At 11:54 7 unknown male subjects all wearing all black, or black and gray approach the business from the North West and enter through the south entrance / exit door of the business. All subjects walk in pairs of two or more throughout the store. One subject breaks from the group and approaches the counter requesting cigarettes. An additional subject walked to the entrance / exit door and held it open as if they were a "look out." All remaining subjects grab multiple items- Gatorade, Arizona Tea, Chips, Donuts, Jack Links beef sticks worth approximately \$50 USD and exit through the southern entrance / exit door at 11:57 AM. All subjects fled South and South East from the location on foot.

While on scene, I observed the licenses posted and they were up to date.

No further information to provide. This concludes my report.

The hearing before the Licenses Committee will take place on 9/9/2025 at 10:25 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
