**NOTICE OF CIRCUMSTANCES GIVING RISE TO CLAIM,
PURSUANT TO § 893.80, WIS. STATS.**

PLEASE TAKE NOTICE that claimants, Hollis Jones and Glenda D. McDonald, by their attorney,

Robert L. Sanderson, state that the following circumstances give rise to claim:

1. That on January 28, 2007, at approximately 8:40 p.m., at or about the intersection of North 35th Street and West Fond du Lac Avenue, in the City and County of Milwaukee, Hollis Jones was driving his vehicle south on 35th Street when a City of Milwaukee vehicle, driven Steven Malone, failed to yield the right-of-way at the intersection, colliding with the Jones vehicle. At the time of the accident, Glenda D. McDonald was a right front-seat passenger in the Jones vehicle.

2. Claimant, Hollis Jones, believes that the City of Milwaukee was negligent as the driver of the City vehicle failed to yield the right-of-way; failed to keep the vehicle under control; and failed to drive at a proper speed.

3. As direct and proximate result of the negligence of the City of Milwaukee and its employees, the claimants sustained injuries as follows:

- (a) Hollis Jones sustained personal injuries and property damage to his vehicle; and
- (b) Glenda D. McDonald sustained personal injuries as a right front-seat passenger in the Jones vehicle.

The claimants continue to require medical treatment and incur medical expenses and loss of wages as a result of the aforesaid injuries.

WHEREFORE, claimants, Hollis Jones and Glenda D. McDonald, claim relief against the City of Milwaukee for wage loss, loss of earning capacity, medical expenses, pain and suffering, and disability, in an amount yet to be determined, which will be included in the claim to be filed, pursuant to statute. This notice indicates claimants' intent to hold the City of Milwaukee responsible for all damages.
