Re: Claim for Stolen Property by Milwaukee Fire Department

This will convey my claim against the City of Milwaukee, pursuant to Section 893.80, Wis. Stats., as described under the City of Milwaukee, Instructions For Filing A Claim Against the City of Milwaukee, for the theft of a Women's Omega Constellation Watch (purchased in Rome, Italy, 1982) and a Colorless Emerald Moissanite Ring.

On November 5, 2024, at approximately 1:00 PM, CST, I telephoned from our home 911. I had come to my wife's assistance after she called out in distress. I immediately took her oxygen level with our INNOVO Fingertip Pulse Oximeter, and it read 32% Sp O2! It should be noted that my wife has Stage 4 COPD. Also, when I got to her bedside, she passed out (lost consciousness) and did not respond to my attempt to gain consciousness. This is when I called 911.

I requested immediate medical assistance for a medical emergency. A Milwaukee Rescue Squad was dispatched and arrived shortly thereafter. My wife, Milena B. Schneiderman, was treated by the City of Milwaukee Fire and Rescue Service at our home (condo, Newport West Condominiums), in our master bedroom.

Initially three (3) men arrived, and a short time later they were joined by two (2) additional men. All five (5) men were present in the bedroom. It should be noted that I was requested to leave the bedroom while emergency services were being provided. I of course complied.

My wife was taken by the Milwaukee Fire Department, EMS, from home to Froedtert Hospital ER, for acute respiratory distress and significantly elevated and dangerous CO2 levels, resulting from not getting oxygen overnight (hours)

because tiny holes were made in her oxygen tubing (by a cat).

My wife was hospitalized at Froedtert after ER treatment and discharged on November 7, 2024. She did not leave our home until November 22, 2024, to be seen by her regular pulmonologist, Rasika Chepuri MD, at Froedtert's Pulmonary Clinic, 8900 W Doyne Ave, Milwaukee, WI 53226. It was when she was preparing for this visit that she first noticed that her watch and ring were not on the dresser where she kept them. After returning home, an extensive search over multiple days was conducted by myself and wife to locate the missing jewelry. The jewelry could not be found. Nothing else was missing, although it should be noted that these two items were the only valuable jewelry in the room.

It was at this time that we determined that the missing jewelry corresponded to the Rescue Squad service, since no one else had been in our home since the time of the service on November 5th and the jewelry was first noticed missing on November 22nd.

I contacted the Milwaukee Fire Department Commissioner's Office to report the "theft" and see how I should proceed in this matter. I do not have an exact date when this occurred, however, the Commissioner's office should have a record of it. I spoke with a person identified as Diane. She took down some information and said she would investigate this matter. I did not hear back from Diane, as she said she would, so after approximately two weeks, I called the office again, and spoke with another person in the office who told me that Diane would be out for an extended period and would get to me when she returned. Moreover, only Diane could help me in this matter.

Diane did telephone me on April 7, 2025. She said she just returned to work today, and wanted me to know that the investigation turned up nothing. And that the Rescue Squad personnel know nothing about the missing jewelry! She suggested that I contact the City Clerk's Office and file a claim for the missing jewelry.

Hence, this claim is filed at this time and not sooner due to the circumstances encountered in the Commissioner's Office.

Enclosed here are the following; to document the value to replace the stolen jewelry:

- Photo(s) of Milena Schneiderman wearing Omega Watch and Ring
- Replacement cost for Vintage Omega Constellation Watch in the amount of \$5,880.00
- Replacement cost of Colorless Emerald Moissanite Ring in the amount of \$1,790.00

- USAA Property Insurance papers documenting ownership of Omega Watch
- Total claim against the City of Milwaukee in the amount of \$7,670.00

Thank you for your consideration of this matter. It is regrettable this action must be taken.

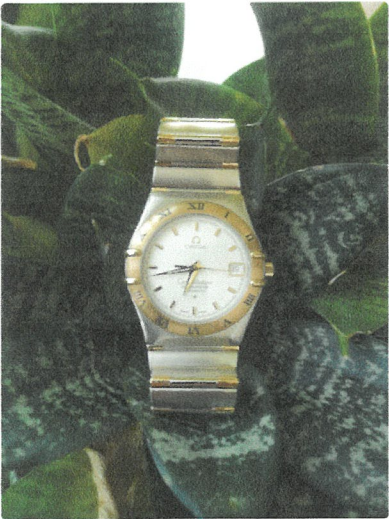
