Location Damage Occurred: Across the street from 3337 N 1st St, Milw, WI 53212

Details of Damage Event: My 2023 Chevrolet Traverse was parked across the street from my house (3337 N 1st Street, Milw, WI 53212), where I parked overnight. The Milwaukee Fire Department responded to an emergency fire call for 2 houses that were on fire across the street from my house.

My car was blocked in by a City of Milwaukee fire engine truck and numerous fire department personnel. At approximately 8:00 am, after the fire was extinguished and the fire engine truck that had blocked my car left the scene, I asked the Battalion Chief (BC), B. McNultry, if my car was damaged. BC B. McNultry responded "there is no damage to cars." I responded, I certainly hope not, as this is my car that was blocked in by the fire truck.

I inspected my car and found what I thought was damage from the fire hoses. There were numerous imprints/marks on the driver's side front to the rear fender, across the back that included the lift gate and back bumper and light covers. I showed these imprints/marks to BC B. McNultry. I also wiped off some of the imprints/marks with my hands. There was white dust like substance all over my car. I advised BC B. McNultry that I would have my car washed to determine if indeed there was damage to my car or not. I asked BC B. McNultry if I had damaged what should I do (the next steps) to get my car repaired. BC B. McNultry advised me to go to the Fire Station on Holton St.

After washing I had my car washed, I discovered definite damage. I went to the Fire Station on Holton St, explained the situation, advised the staff and BC C. Brown that my car was damaged and that BC B. McNultry advised me to come to the station. I completed an MFD Citizen Complaint form (see enclosed). I also advised that I had pictures of my car damage pre-washing my car and post washing my car. BC C. Brown gave me this email address

Bat1@milwaukee.gov I sent pictures of my car damage to the station as requested.

On 5/28/24, I received a call from MFD, I was advised that I would have to file a claim with the City of Milwaukee Clerk's Office. I was provided the Common Council's City Clerk's website for claim information www.milwaukee.gov/cityclerk

Relief Sought: 1) Repair my car 2) pay for the car rental while my car is being repaired.
