

AGREEMENT

between

THE DEPARTMENT OF TRANSPORTATION

and

THE CITY OF MILWAUKEE

This agreement, made and entered into by and between the Wisconsin Department of Transportation, hereinafter called the Department and the City of Milwaukee, hereinafter called Milwaukee, provides for ownership, operation and maintenance of the North Interchange and local streets affected by the construction of the North Interchange (and associated Jobs Corridor projects) and any facilities ancillary to them.

Maintenance of landscaping is not included in this agreement.

DESCRIPTION OF FACILITIES

- USH 41/45, STH 100/145 from Good Hope Road to North 124th Street including on/off ramps and connector roadways
- West Park Place, from North 110th Street to Bradley Road
- Local connector street, over USH 41/45 from West Park Place to STH 145
- West Service Road, Intersection of STH 145 & local connector street to Milwaukee County Park parking
- West Bradley Road, from West Park Place to North 124th Street
- West Good Hope Road, from West Park Place to North 124th Street
- North 124th Street, from West Fond du Lac Avenue to West Brown Deer Road
- West Brown Deer Road, at intersection with North 124th Street
- Old STH 145, at intersection with North 124th Street
- West Leon Road, west from North 124th Street
- West Fond du Lac Avenue, west from North 124th Street

All roadways noted above were constructed or reconstructed as part of the overall construction of the North Interchange (and associated Jobs Corridor projects).

GENERAL

- A. Responsibilities are as outlined in Exhibit A.
- B. It is mutually agreed that the Department will be responsible for the general landscaping maintenance of Department-owned lands, and Milwaukee will be responsible for the general landscaping maintenance of Milwaukee-owned lands except where agreed upon by both parties otherwise.
- C. The Department is responsible for mowing those areas adjacent to the North Interchange (and associated Jobs Corridor projects) that they own.
- D. It is agreed that the lighting ownership/maintenance on bridge B-40-403 is City of Milwaukee's responsibility and includes maintenance on everything from the power sources to the luminaries.

Duration

This agreement shall continue and be in force from this day forward. This agreement may be terminated only by the consent of both parties.
