Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. 2.On 01/29/23 5:56p.m., Milwaukee Police were dispatched to a Strong-Arm Robbery at 1132-A W Lincoln Av. Investigation revealed a subject entered the store multiple times and took items without paying. The suspect pushed the clerk and grabbed the clerk by the shirt yelling profanities. The employees were cooperative with the investigation allowing officers to view video surveillance of the incident.

2. On 06/27/23, Milwaukee Police were working Wisconsin WINS Youth Tobacco Initiative. At approximately 2:10p.m., the youth working with the officer, entered 1132-A W. Lincoln Av., and purchased tobacco from the cashier. The youth stated the cashier did check identification, however, sold the product anyway. The cashier admitted to the sale and apologized. Further investigation revealed this was a Class A Establishment and the sole employee on scene did not possess an Operator License. The officer contacted the co-owner regarding the violation and they were very cooperative and apologetic.

This report is written by PO Penny Monreal, assigned to the License Investigation Unit.

On Saturday, November 12, 2022, I was assigned to work the Wisconsin WINS Youth Tobacco Prevention. Assisting in this assignment was Ricardo GARCIA W/M 09/30/06 of 5221 N. 46th St., and Victor VARGAS-DIAZ W/M 07/31/05 of 2406 S. 10th St. Neither GARCIA or VARGAS-DIAZ are of legal age to purchase tobacco.

At approximately 09:24A, GARCIA entered Danny's Foods, located at 1132-A W. Lincoln Av. and purchased a pack of Newport 100's cigarettes. GARCIA described the employee as an A/M wearing a black leather jacket, with black hair and eyeglasses. GRACIA stated the employee did not ask or check his identification.

I entered the store and identified the employee based on the description given. The employee was identified as: Meet N. PATEL A/M 05/02/01. PATEL admitted to the sale, however, stated he asked the customer his age and the customer stated they were 21. I advised PATEL they are trained to provide ID if requested as well as to tell their real age if asked. The manager on scene came out of a back room and was identified as: Shaileshkumar A. PATEL A/M 04/22/84. PATEL stated he was part owner of the establishment, however, was not the listed agent. Due to the fact this was a Class A establishment, I requested to see an Operator License. Meet PATEL stated he did not have one, and S. PATEL stated his was coming in the mail. I advised S. PATEL I would check LIRA (License Information Reporting and Administration) to verify he did in fact have a valid Operator License and if he did not, I would be issuing a citation for the violation. S. PATEL stated he understood. A check with LIRA revealed S. PATEL is a 75% Shareholder, however, is not the Agent of the establishment. Patel was also cited for Responsible Person On Premise Required, CIT #0682QT5JNM.

I attempted to contact the agent: Dixitkumar PATEL to advise him of the violation, however, only received a voicemail. I left a detailed voicemail advising him of the same.

Business was the victim of a strong-arm robbery. The subject with the Class D Operator's license was a cooperative victim regarding; Shaileshkumar A. PATEL (A/M 4-22-1984).

PATEL stated that a h/m, with a black winter hat, a black full beard, a black hooded sweatshirt and dark colored pants came in to Danny's Liquor and Food originally at approximately 5:56P with an unknown b/m wearing a red hooded sweat shirt and light colored jeans. The suspect came into the store and went to the cooler, grabbed two 6 packs of Heineken beer. The suspect got verbally aggressive and pushed PATEL and grabbed him by the shirt stating "Fuck you" and pushes PATEL and leaves the the store.

At approximately 6:00P the same suspect comes back into the store. The suspect takes a box of pistachios, valued at approximately \$50.00, proceeds to yell some more profanities at the PATEL and then leaves.

At approximately 6:01P the suspect comes into the store again and takes a box of beef jerky, yells some more obscene comments at PATEL and takes a handful of lighters and throws them at PATEL and then leaves.

The suspect then comes back at 6:03P pushes a large glass container of pickles resting on the checkout counter over the back side at PATEL and grabs him, yelling more obscenities and demands that he gives him a bottle of Remy Martin, valued at \$30.00 and a bottle of Bombay Sapphire, valued at \$14.00 and then threw a lighter at PATEL and left the store.

The store has quality video footage of this incident which matches PATEL's explanation of this incident. This video was not able to be downloaded.

On Tuesday 06/27/23, I was assigned to work for the Wisconsin WINS Youth Tobacco Prevention, which checks area vendors for age compliant tobacco purchases. Assisting in this assignment was Maurice L. NEWTON B/M 01/27/06 of 5102 S. Nicholson Ave., Cudahy, WI 53110. NEWTON is 17 years old and not of legal age to purchase tobacco.

At approximately 2:10p.m., NEWTON entered Danny's Liquor, located at 1132-A W. Lincoln Ave., and purchased White Owl Strawberry Flavored Cigars. NEWTON described the employee as A/M wearing a green shirt, with black hair and was the only employee in the store. NEWTON stated the employee did check his identification, however, sold anyway.

I entered the store and identified the employee based on the description given. The employee was identified as: Jayvin PATEL A/M 11/13/2000. Due to a language barrier, PATEL contacted the owner who identified himself over the phone as Shaile PATEL. S. PATEL translated and J. PATEL admitted to the sale and apologized. Since this is a Class A establishment, I asked S. PATEL if J. PATEL had an Operator License, to which S. PATEL stated he only left for a few minutes to run to the bank and all licenses were locked in the office. I advised S. PATEL that under no circumstances can he leave an employee alone without a licensed person on scene or a valid Operator License. I explained I would be issuing citations for both violations.

A check with LIRA (License Information Reporting System) revealed the agent is Dixitkumar PATEL A/M 07/30/88. I contacted D. PATEL and advised him of the situation. D. PATEL stated he fired the employee after he viewed the camera system of the incident. I advised D. PATEL that no licensed bartender was on scene. He stated he understood, and S. PATEL only left for a few minutes. I advised I would still be issuing a citation for the violation. D. PATEL stated he understood and apologized.



The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 9/6/2023 at 2:20 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
