Repairs are going to cost in the neighborhood of \$1000.00, but beyond the cost issue I feel obliged to compel the responsible parties to own up to the damage that they've done.

I will be informing my friends and family about this experience, and question whether I will continue to live in the City or move back to a suburban setting where parking is not such a hassle. Your response to my legitimate claim so far is very disappointing.






