Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. INITIAL INVESTIGATION

This report was written by Police Officer Fabian Garcia assigned to District Six-Early Power, Squad 6264.

On Thursday, September 17, 2020, at 3:18 pm, my partner Police Officer Michael WARD and I, along with Squad 6216, Sgt. Christopher McBRIDE assisted the State of Wisconsin Department Of Revenue with execution of a Tax warrant at the 13th Pour located at 3675 S. 13th Street.

Agents on scene were, Special Agent Georgeann KING and Special Agent Kurt GOODREAU with the Alcohol and Tobacco Enforcement. Revenue Field Agent Rick MARTINEZ and Revenue Agent James SCHLEICHER with the Compliance Bureau Income, Sales, and Excise Tax Division.

As we entered the bar using the north entrance door, I observed approximately 10 patrons in the bar, who had what appeared to be alcoholic beverages on the bar counter top. I observed one bartender who was identified by Wisconsin drivers license as Jennifer M. ZOLINSKI (w/f, 05/10/79) standing behind the bar. Special Agents identified themselves and stated why they were there and presented ZOLINSKI with a tax warrant. All patrons inside of the bar where asked to leave, which they did without incident. ZOLINSKI was able to make contact via phone call to listed owner Eric B. SCHNEEBERG (w/m, 12/14/72), who stated he would be on his way to the bar and would be coming from his place of residence.

While on scene, ZOLINSKI did provide myself and the Special Agents on scene with a valid Class D bartenders license (0229462) which is valid from 1/1/19 to 12-31-20. ZOLINSKI did state that she knew that the bar did not have a liquor license but stated that she was advised by SCHNEEBERG that everything was taken care of. ZOLINSKI was asked if the west end of the bar, which had a door that was slightly ajar leading to what appeared to be personal living area was part of the tavern, ZOLINSKI replied it was not. The living space appeared to not be occupied as a residence and had ZOLINSKI's personal items on top of a kitchen counter and also had a large screen with multiple screen boxes of surveillance footage of the bar.

SCHNEEBERG arrived on scene and spoke to the Special Agents who advised him of the circumstances regarding this warrant. Let it be noted that during the investigation SCHNEEBERG was cooperative and answered all of the Agents questions. SCHNEEBERG did admit to Special Agent KING that he knowingly knew that his Class D Liquor license had expired and was still selling alcohol to patrons and keeping his

business open. SCHNEEBERG also stated that he purchases his liquor from a retail liquor store located at 4075 S. Howell Avenue, Avenue Wine and Liquor. SCHNEEBERG also stated to Agent King that some liquor bottles are refilled brand for brand. SCHNEEBERG was advised that he would be issued a citation for illegal distribution of alcohol with an unlicensed premise (citation number J980V7MLWD). This concludes my report.

This report is written by P.O. Joel BUNKELMAN, assigned to District 6, Late Power shift, squad 6468.

On Saturday, October 31st, 2020, P.O. Manuel LUCENA-MARTINEZ and I conducted a routine "Tavern Check" at the 13th Pour, located at 3675 S 13th ST in the city and county of Milwaukee. We were both wearing full issued Milwaukee Police Department (MPD) uniforms with sewn on badges. We were also equipped with Axon body worn cameras (BWC).

We entered the bar from the north entrance. Inside there were multiple people sitting at the bar drinking alcoholic beverages. We were promptly greeted by the bartender that was on duty. She identified herself as Jessica M RICK (WOOD)(w/f 2-9-78). We identified ourselves and stated that why we were there. I asked to see her bartenders license. RICK was able to producer her bartenders license (#233635 exp. 12-31-2021) along with a picture ID. I then asked RICK if she knew where a copy of the tavern license was. RICK was unable to locate it but immediately called the agent, Eric B SCHNEEBERG (w/m 12-14-72). SCHNEEBERG stated that he only received his license by email but had not received a paper copy yet from the city. I conducted a check through L.I.R.A. which showed that the bar had a license granted (#208220-20 exp. 10-12-21) on October 13th, 2020 and was current and active.

SCHNEEBERG was advised that he needed to print a copy of the license and post it in a visible area of the establishment. He stated that he would print off a copy and post it in the bar first thing in the morning.

All parties were very helpful during the entire interaction.

The hearing before the Licenses Committee will take place virtually on 9/28/2021 at 1:45 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


