Operating Agreement for the 2024 Milwaukee Marathon

Special Event Ordinance

MCO 105-55.5-2-c: Approval or Denial of Permit

The commissioner shall issue a permit unless:

c-1. The special event is of such a size or nature requiring the diversion of so great a number of police officers, ambulances or other emergency services as to deny reasonable emergency services to the city as a whole.

c-2. The time, route, size and nature of the special event will unreasonably disrupt the safe and orderly use of any street or any public place, or material portion thereof, which is ordinarily subject to great congestion or traffic at the proposed time, or substantially interrupt the safe and orderly movement of other traffic.

Operating Agreement for the 2024 Milwaukee Marathon

Permit is denied and the applicant works with City departments to create an operating agreement. The operating agreement is the contract between the applicant and the City which details the applicant's responsibilities:

Details needed for the permit application (route map, traffic control plan, security plan, emergency plan, notification plan, clean-up plan, mitigation of impacts on affected properties, permits with outside agencies)

Timeline of payment for City services (MPD, DPW)

Indemnification and Insurance

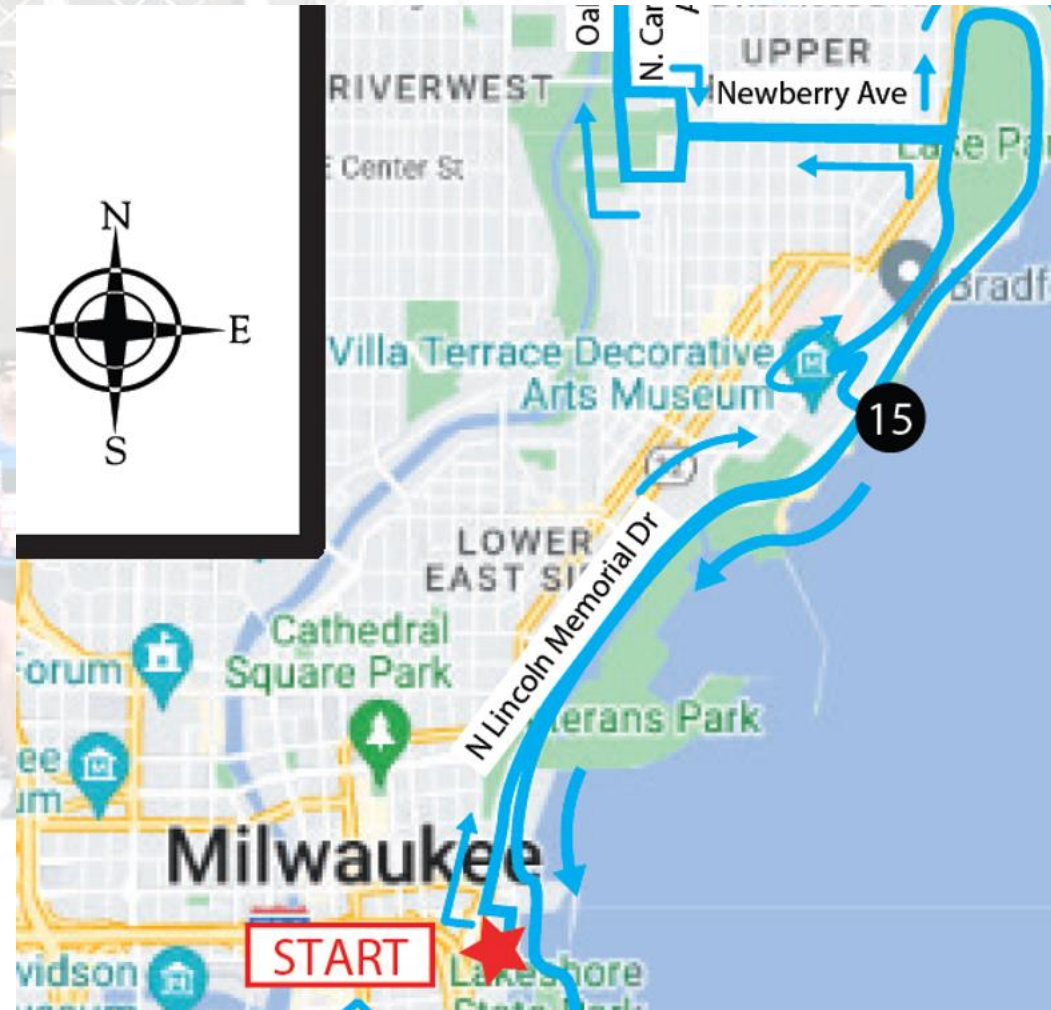
Starts and Maier Festival Grounds

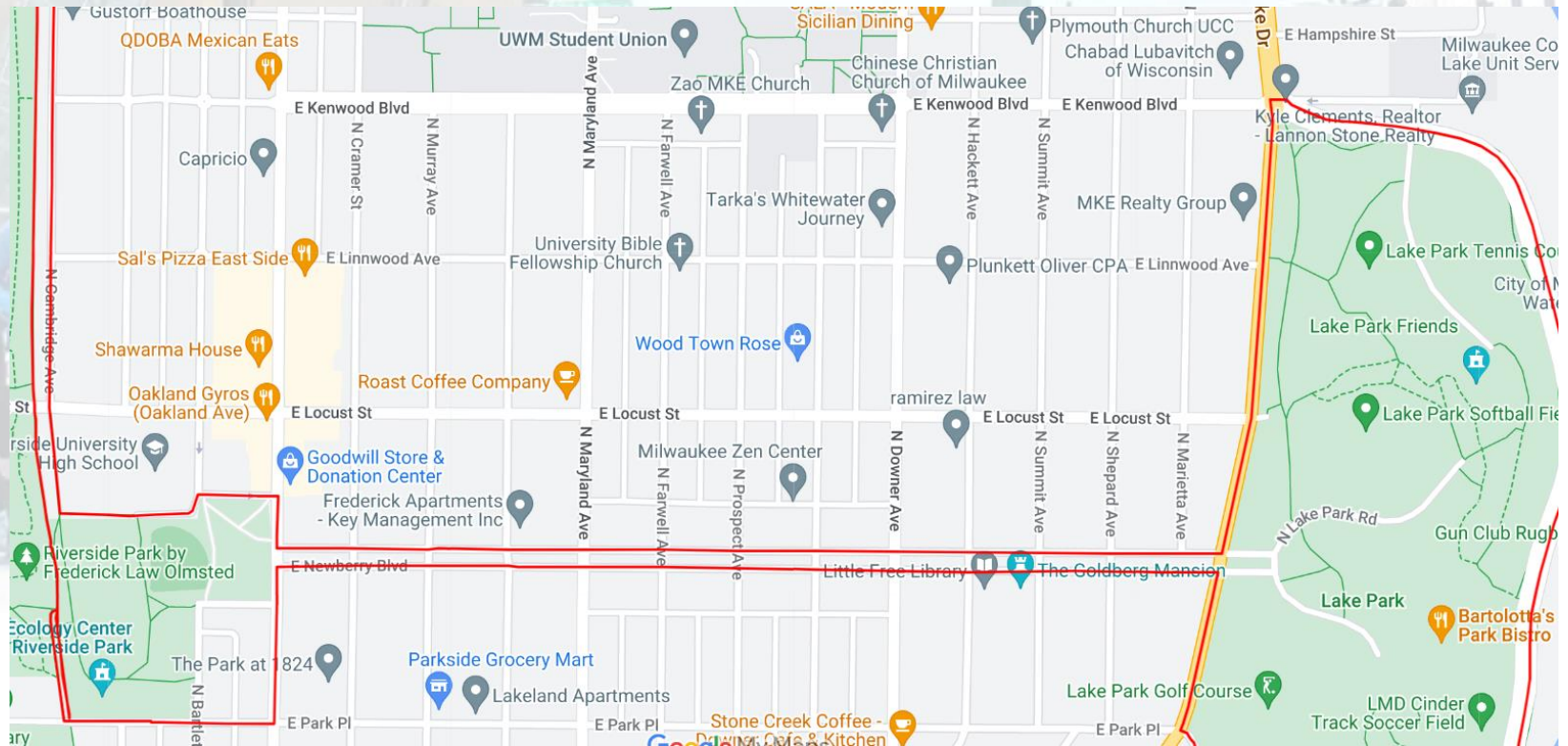

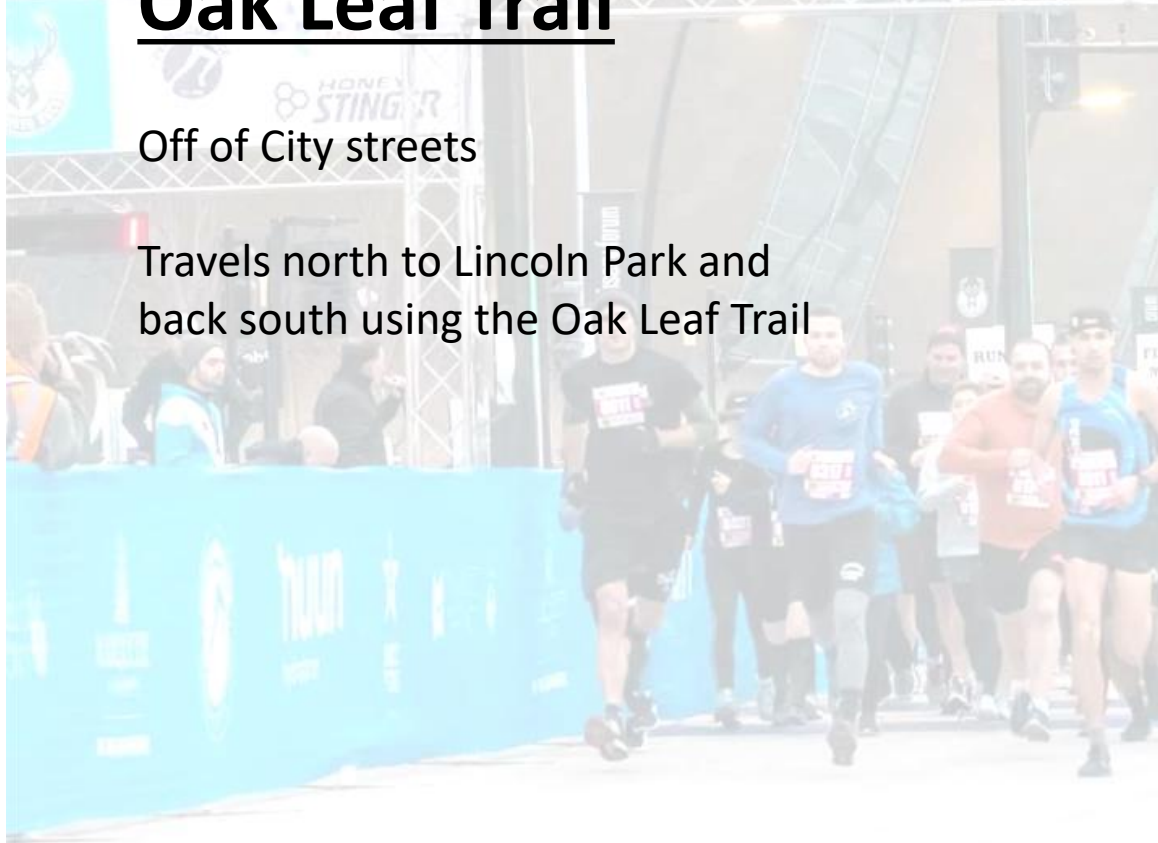
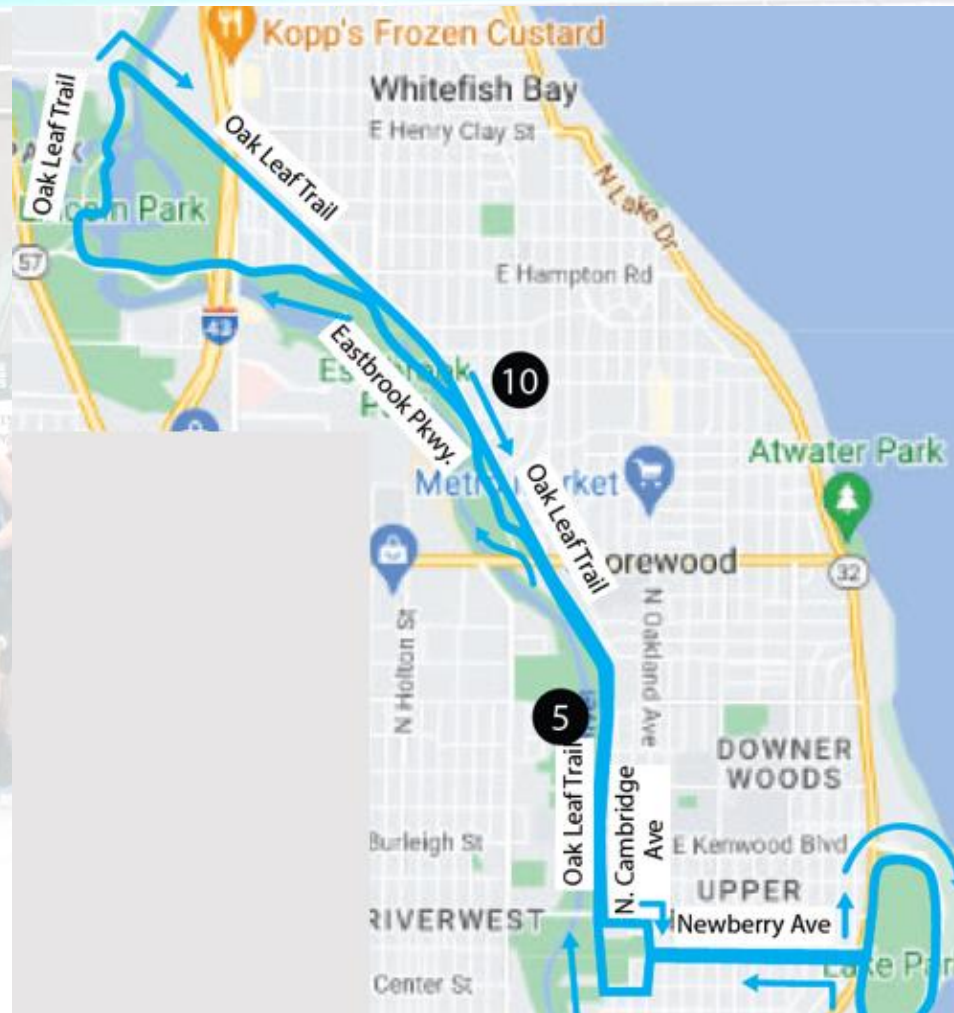

Heads east on Clybourn to the Hank Aaron State Trail on the Maier festival grounds

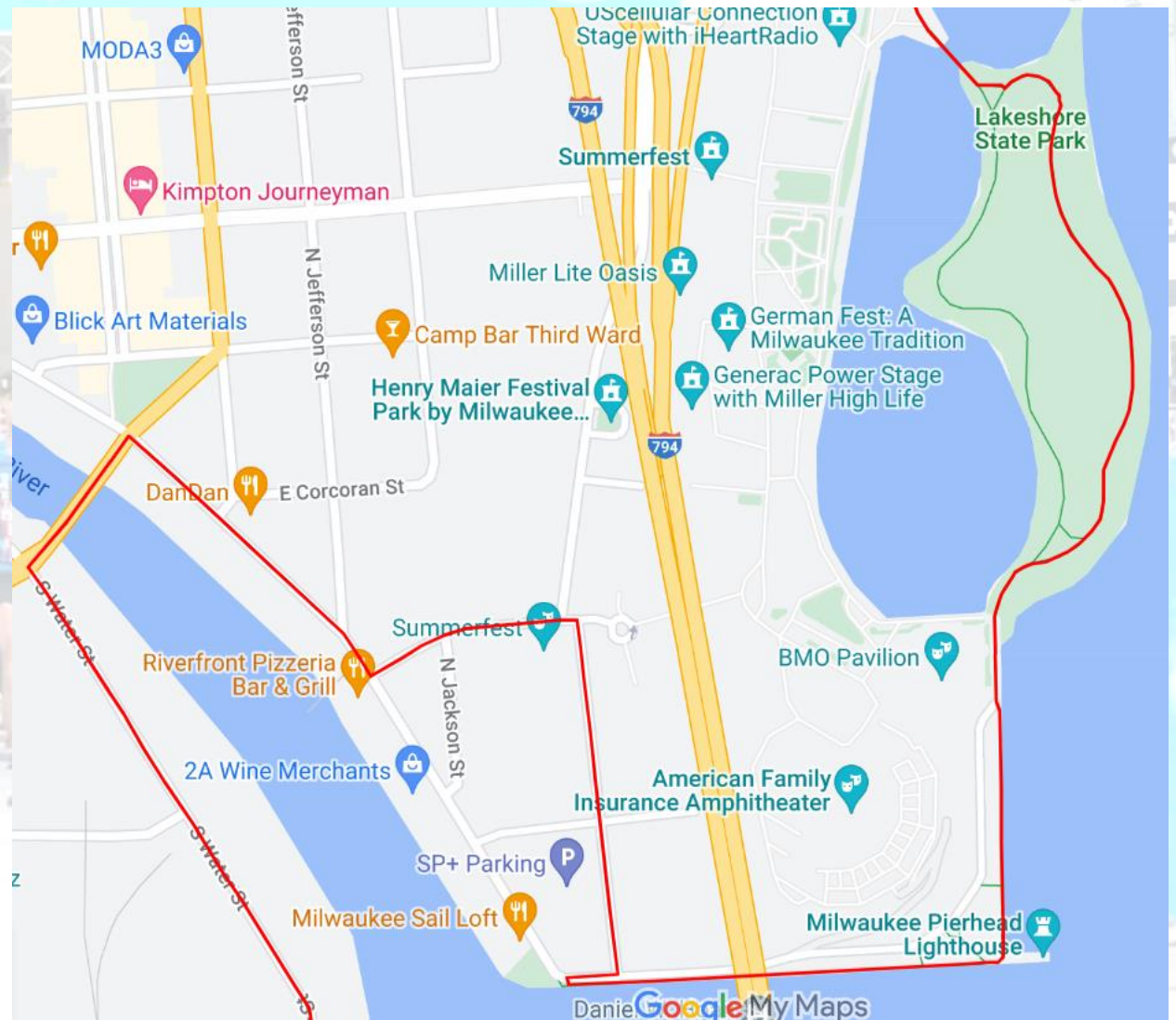
Exits Maier festival grounds at Summerfest Place

Crosses Broadway Bridge

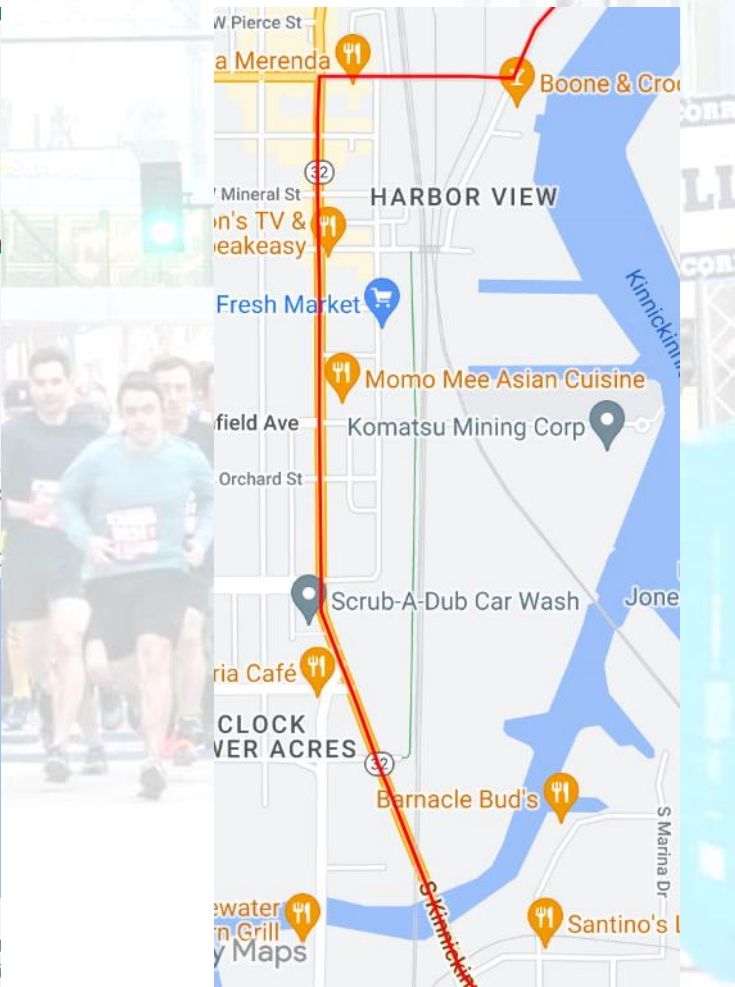
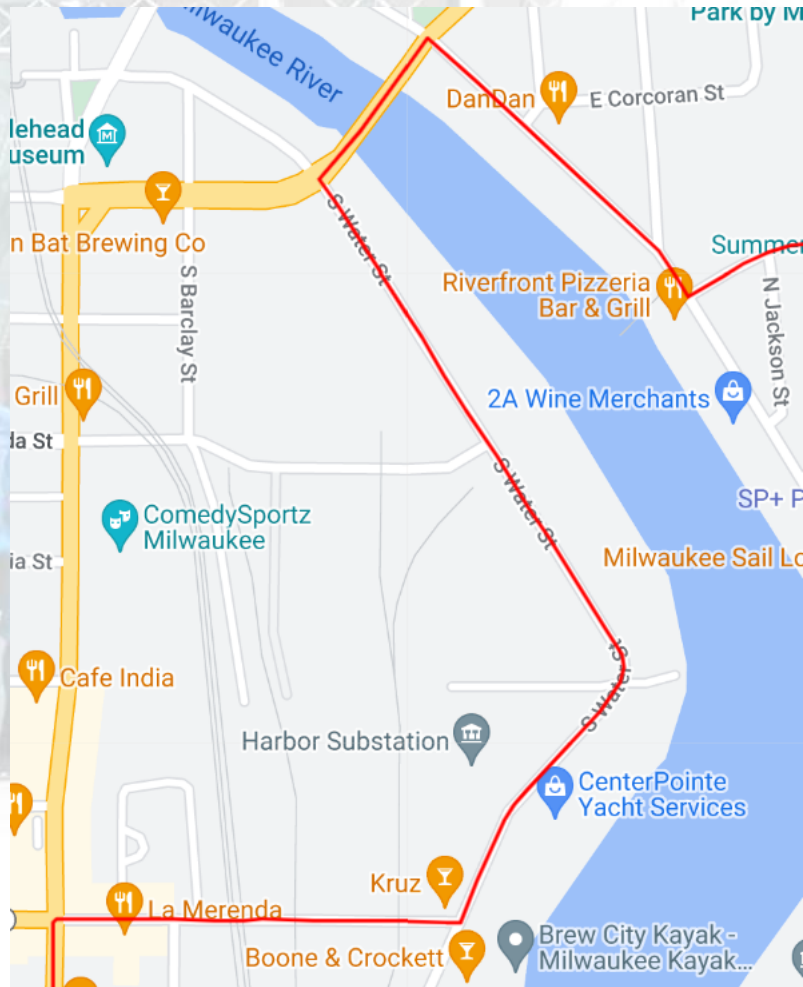
