Dear Ms. Powell:

We are in receipt of your claim regarding damages sustained on May 15, 2023, allegedly caused by a City garbage truck, located at or near E. North Avenue and N. Humboldt Boulevard.

A Fleet Services report was completed as a result of this alleged incident that occurred while you were traveling north bound on N. Humboldt Boulevard when an unknown garbage truck made contact with an orange barrel and struck your vehicle. No license or vehicle number of the City of Milwaukee garbage truck that allegedly caused damage to your vehicle was supplied in your claim.

There is no evidence that your vehicle was damaged by a City vehicle. Because of this lack of evidence, we cannot accept liability. As such, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.

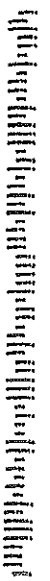

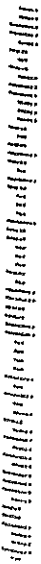

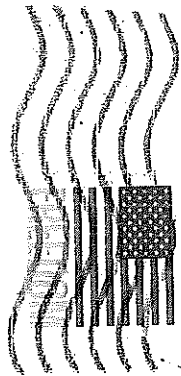
