As an almost lifelong eastsider who lives, works and plays on the eastside, I am writing to state my vehement opposition for renewing the Class B Tavern License for the Miramar Theatre on N Oakland Avenue. There has been a variety of violent crime and fights breaking out both inside and outside the theatre, cars vandalized and more. The university campus neighborhood does not need a venue like this bringing more violence to the eastside.

Nor should a liquor license be issued for the former Bikesmith's location on North Murray and Locust. The eastside has numerous head shops and Park Ave Foods within two blocks of this location. Locust and Cramer Locust and Murray already are starting resemble the student ghetto of Madison with rundown housing, litter, trash and debris--including furniture across people's parkways. The lack of owner occupied duplexes in this area encourages less caring about the neighborhood, and leads to more crimes of opportunity.

Please do not renew the Miramar license and do not approve a liquor head shop license for the Bikesmith location.

I am in my 20s myself, I've lost a lot of friends and family to overdoses and drunk driving. I feel as though Aaron's venue is not a safe place. I've known too many people to bring "party favors" there and have not attended any concerts there for that reason alone before the site 1a incident.
