There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Partnership applicants must appear by a partner listed on the application or by an attorney. This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/09/2018 officers were dispatched to a fight at Tu Casa, 3710 W. Lincoln Av. When the officers arrived they found security had two subject detained. The subject were intoxicated and refused to leave the bar. When they were being escorted out they made threats to security, which is why security detained them. The applicant was on scene and stated she just wanted the subjects to leave. The subjects were told to leave and were banned from the property.
2. On 12/14/2018 at 1:57am officers were dispatched to shots fired at Tu Casa, 3710 W. Lincoln Av. The officer interviewed the applicant who was on scene. She stated there was a verbal argument in the tavern earlier at about 1:00am but they closed the tavern to avoid further conflict. She did not hear gunshots. The applicant's husband, Marcos ISIDORO-GAMBOA, stated he was outside at closing and there were two fights outside but he did not hear any gun shots. The sole security guard stated she attempted to use pepper spray to stop the fights and did hear about 5 gunshots. The officer watched the security footage which showed about 40 subject exiting and arguing. He observed one subject exit the tavern and engage in a verbal argument. During the argument the subject produced a firearm and pointed at the other subject. The subject with the gun left in a car and then subjects on scene were observed ducking. No one from bar called the police. The applicant was cooperative and was advised to call the police in the future if something happens at the bar.

3. On 01/27/2019 officers were dispatched to Tu Casa, 3710 W. Lincoln Av for a Trouble with Subject. Marcos ISDORO was on scene and stated that a subject was denied entry due to his dress code and as he was leaving he threatened to shoot the tavern up. ISIDORO requested the officers stay in the area in case the subject returned.
4. On 01/29/22 at 1:28am, Milwaukee Police were dispatched to 3710 W. Lincoln Av., for a Trouble with Subject. Officers observed an intoxicated patron outside of the bar, unconscious but breathing. Officers could smell the odor of liquor emanating from the patron. Officers were advised by the owner the subject was kicked out of the bar for being disorderly. The patron and a friend then attempted to re-enter the establishment, and were denied re-entry. The patron then began to become aggressive at which time security had to push the patron back, causing him to fall to the ground. Officers did not observe any bumps or lacerations to the patron. Officers then assisted the patron and his friend into their vehicle, where the disorderly patron began to respond to stimulus by the officer. No medical attention was requested by either patron.
5. On 02/12/2019 a meeting was held at District 2 regarding Tu Casa, 3710 W. Lincoln Av regarding shots fired on 12/14/2018 and an abduction on 01/01/2019. At the meeting was the applicant; her husband, Marcos ISIDORO; and owners of Midwest Private Police Inc. ISIDORO stated the shots fired was not related to his business because it happened outside and down the street. He didn't call police because someone else said they were calling. He was advised that he was responsible for his patron's action outside as well as inside and he should not have his patrons parking in the parking lots of neighboring businesses. Regarding the abduction ISIDORO stated he was asked by a patron to look at video for whom the abducted patron left with and he advised that person to call the police. He stated he then allowed the police to view the surveillance video.

6. On 07/29/2019 at 12:45am officers were dispatched to Tu Casa Restaurant, 3710 W. Lincoln Av for a Battery complaint. The victim stated she was at the bar and her ex-boyfriend hit her to the face. The business was cooperative and provided video of the incident.
7. On 12/20/2019 at 2:11am officers were dispatched to Tu Casa, 3710 W. Lincoln Av, for a Trouble with Subject. The officers spoke with security, who stated there were two males in the restaurant refusing to leave at closing. After they left the security guard heard 5-6 gunshots. The officers checked the area but did not locate the subjects. The manager stated he did not witness the incident but did provide video of the subjects leaving.
8. On 01/01/2020 at 3:31am officers were dispatched to a fight at 3710 W. Lincoln Av. The officer spoke with security who stated two subjects had an argument. One subject left and the other was argumentative with security, who placed the subject in handcuffs and called police. The manager was cooperative with the officers.
9. On 01/29/2020 at 1:00am officers were dispatched to a Subject with weapon complaint at 3710 W. Lincoln Av. The officers spoke with security who stated two females were fighting. One of the females was still on scene. She confronted a female who had an affair with her husband. She pushed the subject to the ground. The security guard used pepper spray to stop the fight and one of the subjects left the scene. The applicant was on scene and requested the female be issued a no trespassing order.

10. On 02/16/2020, at 1:22am officers were dispatched to a fight at 3710 W. Lincoln Av. Upon arrival they were told two females were fighting. Both females were on scene and appeared to be intoxicated. The subjects did not want to prosecute and were released.

11. On 09/07/20 at 12:25am, officers were dispatched to a Subject with a Gun at 3710 W. Lincoln Av. Officers were advised an altercation occurred between security and a patron. The patron who was heavily intoxicated was being asked to leave the bar, at which time the patron struck the security guard multiple times in the face with a closed fist. Management was on scene and was cooperative with police.

12. On 10/04/20 at 2:25am, officers were flagged down by security at 3710 W. Lincoln Av., for a fight. Officers observed approximately 20 patrons standing outside and began to disperse as officers arrived. A victim was observed on the ground and stated he was punched, however, did not know who hit him and did not wish to be a victim. The manager was on scene and stated he had approximately 50 patrons and 2 security guards. The manager denied knowledge of a fight outside and was advised to have more security when he has a crowd of that size. Management was cooperative and allowed police to view video surveillance, however, the fight was not captured.

13. On 05/04/21 at 8:33pm, officers along with an agent from Department of Revenue conducted a license premise check at 3710 W. Lincoln Av. All receipts and records of alcohol purchases were provided and valid. No violations were found and the agent was cooperative with police.

14. On 04/23/22 Milwaukee Police were dispatched to 3710 W. Lincoln Av., for a Subject with Weapon. Officers were advised a patron attempted to take beer outside of the establishment. Security stopped the patron and an argument ensued, escalating to security eventually using pepper spray on the patron. Employees were cooperative and allowed officers to view video surveillance of the incident.

15. On 05/30/22 at 2:08am., Milwaukee Police were dispatched to 3710 W. Lincoln Av., for a Battery. Officers were advised an intoxicated patron was escorted out of the establishment due to an argument. The unruly patron then returned and a verbal argument ensued between the DJ and the patron, when the DJ is seen on video surveillance punching the patron one time in the face. The employees were cooperative with the investigation and allowed officers to view video surveillance of the incident.

16. On 06/19/22, Milwaukee Police compiled a report per an Aldermanic request, regarding calls for Shots Fired at 3710 W. Lincoln Av. There were 5 prior calls for Shots Fired in the area of 3710 W. Lincoln Av., in the previous License Cycle.

17. On 11/06/22 at 1:45a.m., officers were dispatched to a Subject with Gun at 3710 W. Lincoln Av. Prior to arrival the officers were provided a description of a subject in a white 4 door vehicle, with a long gun on the front seat. On arrival, officers observed a vehicle matching the description, however, upon attempting to stop the vehicle, the vehicle fled the scene. Investigation revealed security kicked out a patron for attempting to do drugs in the patron. The patron then goes to their parked vehicle and places what appears to be a long gun in the front seat. At no time did the patron make any threats or point the possible gun at any one.
18. On 01/19/23 at 10:33p.m., officers conducted a License Premise Check at 3710 W. Lincoln Av. This was in regards to a recent non-renewal of the PEP License. Officers interviewed the agent, who stated they were aware of the decision.
19. On 04/22/23 at 1:50a.m., officers were dispatched to a Shots Fired at 3710 W. Lincoln Av. The agent was on scene and was cooperative allowing officers to view video surveillance of the incident, which depicted a subject in the side lot of the bar enter their truck and fire several rounds into the air. Officers recovered eight spent shell casings in the lot.
20. On 04/22/23 at 1:50a.m, Milwaukee Police were dispatched to a Shots Fired, which was later determined to be a Battery at 3710 W. Lincoln Av. On arrival officers interviewed the victim who stated he was punched by a subject while leaving the establishment. This caused the victim to fall to the ground at which time he was kicked, punched and dragged by 5 males that he believed to be gang members. Further investigation revealed two additional victims, Medical was called and two victims were transported to the hospital. Video surveillance depicted a group of subjects fighting outside of the premise. Due to poor video quality, the identity of the subjects could not be determined.

This report is written by P.O. Kevin VODICKA/P.O. Matthew DIENER assigned to the District Two Community Prosecution Unit. The District Two CPU received a request from the office of Ald. ZAMARRIPA to detail "Shots Fired" calls for service, year to date, in the area of S 37th St and W Lincoln Av.

The following are only summaries of the related reports, if any, and only include relevant information and incidents:

05/21/22 CAD #221410162 IR #221410019 - On Saturday, May 21, 2022, at 2:26 AM, officers were dispatched the area of 37th and Lincoln to a "Shots fired" call. Upon arrival officers located seven 9mm Casings in the middle of the alley of 37th and Lincoln Ave. We looked around the area and nothing was struck. Residents stated that they heard an argument, shots fired, and a vehicle speeding off. Camera footage was reviewed from Tu Casa at 3710 W Lincoln Ave, which shows a red 4dr sedan going through the alley. A firearm appears from the driver side and discharges into the air and flees going westbound through the alley and then S. bound on 38th st. I was unable to get a description of the drive or plate for the vehicle. We were unable to get the video footage, because we were having an issue transferring the video onto a USB drive. No structures were struck, casings were recovered and inventoried.

05/07/22 CAD #221270171 - On Saturday, May 7, 2022, at 2:22 AM, officers were dispatched to S 37th St and W Lincoln Av to investigate a report of "Shots Fired". The caller stated that they had just heard shots fired outside of Tu Casa. Officers were unable to locate any evidence or objects struck.

03/21/22 CAD #220800113 - On Thursday March 21th 2022, at 1:32 AM, officers were dispatched to the area after West Milwaukee Police Officers reported hearing "shots fired" in the area of S 37th St and W Lincoln Av at 1:25 AM. Officers were unable to locate any evidence or objects struck.

INITIAL INVESTIGATION

Gnas, Tyler D 026046

This report is written by P.O. Tyler GNAS assigned to District Two Late Shift.

On November 06, 2022 my partner P.O. Traves MARTIN and I were dispatched to the address of 3710 W Lincoln Ave (Tu Casa Restaurant and Bar) for a subject with gun call for service. The CAD described an hispanic male in a white Lincoln 4door vehicle with a long gun in the front seat of his vehicle sitting in front of the location.

Upon arrival we traveled westbound through the alley just north of the location and observed a vehicle matching the description. While traveling through the alley a security officer for the bar pointed the vehicle out to officers. officers attempted to stop the vehicle to investigate what exactly occurred that caused police to be called. The vehicle immediately fled from officers heading eastbound on Lincoln Ave.

We then came back to the restaurant to speak with the caller. The caller, who identified himself as Tyler C NULL (W/M, 01/21/1996) and as the security Supervisor, stated that he had kicked a hispanic male subject out of the restaurant for attempting to ingest cocaine in the bathroom of the restaurant. NULL described the subject as a shorter hispanic male wearing a white t-shirt. NULL has seen the subject in the restaurant on numerous occasions but has never had any run-ins with him acting like this. NULL also stated that they have kicked the subject out of the restaurant multiple times in the past. NULL stated that after kicking the subject out of the restaurant the subject went to his vehicle, identified by NULL as a white 4 door Lincoln, parked across the street and appeared to place a long gun into the front seat of the vehicle. NULL immediately corralled any patrons who were standing outside back into the bar. NULL stated that he could not tell if the gun was real but that the subject did not point the gun at anyone. The subject did not make any statements towards anyone and just sat in his vehicle. NULL stated that the subject is no longer allowed back into the bar. NULL was advised to call back if the subject came back to the location.

INITIAL INVESTIGATION

This report is written by Police Officer (P.O.) Quentin C. ARNOLD, assigned to District Two, Late Power Shift, Squad 2432 partnered with P.O Antwan POWELL. Officer POWELL and I were equipped with an AXON body worn camera, which captured this investigation.

On Thursday, January 19th, 2023, at approximately 10:33 P.M., Squad 2432 Officer POWELL and I (While in full duty Milwaukee Police Uniform with the Milwaukee Police Badge on our outer most garments, operating a marked Milwaukee Police Squad 546 equipped with operating emergency lights and audible siren) conducted a tavern check at the address of 3710 W. Lincoln Avenue located in the City and County of Milwaukee, WI.

We were conducting a tavern check regarding the recent court decision of not renewing their PEP license and all options to appeal have been exhausted. My partner and I entered the premise through the front door and made contact with the owner ISIDORO-GAMBOA, MARCOS. I asked ISIDORO-GAMBOA if we could relocate to a quieter area which he complied.

I asked ISIDORO-GAMBOA if he was aware of his PEP license status, and he stated he was aware not to have any DJ's or anything of that nature. Upon arrival, we began to look for spent casings at the location, and in the side parking lot near the address of 3716 W. Lincoln Ave, eight total spent casings were recovered. Upon talking to the residence of 3716 W. Lincoln Ave, he stated he heard what appeared to be firecrackers. And did not wish to provide information to identify himself. Each spent casing that was recovered was covered by orange traffic cones, to identify where the casings were recovered.

Upon entering the restaurant / bar at the address of 3710 W. Lincoln Ave, P.O James SPINATO and P.O Alondra SANTIAGO were speaking with one of the two owners Marcos ISIDRO-GAMOA (H/M 01/22/1979) who was showing them video surveillance and revealed that the subject of the E.S.B.U.O.D.W. was outside in the side lot of the bar/restaurant, then goes into his red pick up truck and shoots into the air. The subject was identified as Jorge M. GIMENEZ (H/M 11/17/1980) by the owner. After the shots were fired GIMENEZ went to the porch of the address of 3716 W. Lincoln Ave, and spoke with the individual who did not wish to be identified. Footage also shows the un-identified individual was outside at the time of the shots fired.

A witness was outside the restaurant front identified as Carol A. FARIAS (W/F 06/11/1974) who was in her vehicle at the time of interviewing. She stated she saw a person in a brown vest, and heard the shots and didn't see where the individual went after the shots were fired.

All eight casings that were recovered were documented and individually placed in envelopes. All Eight Spent casings were Brass Federal 40 S&W.

The bar was cooperative, showed video and all license were valid.

On Saturday April 22, 2023, at approximately 1:50 am, Squad 2320 (P.O. Victor HERNANDEZ) was dispatched to a shots fired complaint which was later determined to be also be a battery at the location of 3710 W Lincoln Av (Tu Casa) which is located in the City and County of Milwaukee.

Upon arrival at the scene and after scene was secured, P.O. HERNANDEZ observed a black 2013 Audi A6 (WI PI# AJT-3694) with tinted windows and three subjects inside the vehicle facing eastbound on the 3700 block of W Lincoln Av. P.O. HERNANDEZ made contact with the unknown male who was seated in the driver's seat and observed him to have a swollen lip and bruising on his face. The unknown male later identified himself as Jesus HUERTA-PARRA (W/M 12/25/93). HUERTA-PARRA stated that he was blindsided by 5 unknown males while leaving the establishment.

HUERTA-PARRA stated that he thought the 5 unknown males were a gang. HUERTA-PARRA stated that once he was blindsided from a punch to the left side of his face, he fell to the ground and was then kicked, punched and dragged to his car by the 5 unknown males. HUERTA-PARRA stated that he believed his jaw was broken and complained from pain.

P.O. HERNANDEZ offered HUERTA-PARRA medical assistance which he stated, "get me an ambulance please" and officers requested medical. While waiting for medical the male in the rear seat of the vehicle who identified himself as Omar VASQUEZ-HERNANDEZ (W/M 02/16/96) also requested medical assistance as he stated that he was also battered by the group of males and felt his right eye was bruised as he could not fully open it. The third occupant who was seated in the passenger seat of the vehicle who identified himself as Diego MARTINEZ-LICON (W/M 11/13/95) stated that he was also involved in the altercation but did not get to see any of the suspects involved. MARTINEZ-LICON refused medical attention

Curtis ambulance 320 responded to medical request. HUERTA-PARRA and VASQUEZ-HERNANDEZ were then assessed on scene and were advised to get further medical treatment. HUERTA-PARRA was then conveyed to St Luke's Hospital and admitted at 2:59am and was under the care of NP David JAETTON.

Medical assessment revealed both HUERTA-PARRA and VASQUEZ-HERNANDEZ only suffered minor bruising and minor concussions. St Luke's staff medically cleared HUERTA-PARRA and VASQUEZ-HERNANDEZ as they did not sustain any fractures or internal bleeding.
