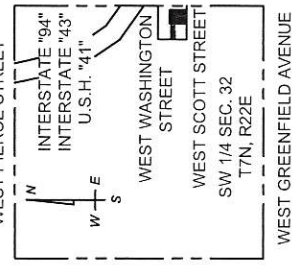

Dedicating the easterly 2.00 feet to the City of Milwaukee for public purposes purposes.

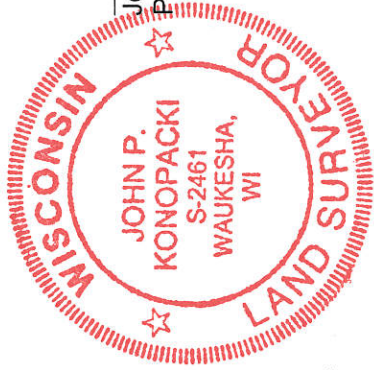

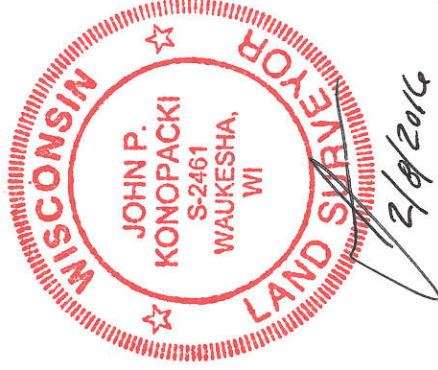
