1. I do own this house, I just didn't change the name on deed after my divorce. My name was Mary Jabkiewicz.
2. The neighbor did tell the police to stop the owner is on the phone and wants to talk to them, I was on the phone and heard her yelling.
3. There is no way anyone saw any cats. The cats are terrified of strangers and loud noises so they could not have seen a cat anywhere near a phone or anywhere else. The cat sitter and her daughter came to look for the cats, less than an hour after the police left, to make sure none of them got out and they were still all hiding, it took them a good 30 minutes to find all 3 of them.
4. Yes the cats were making noise, but if the police would have taken my call, they would have gotten into the house in a few seconds instead of the 10 minutes or so it took to break in the door.

I can get all three of the people who helped me that day to give notarized statements.

Meg Correa - The neighbor who tried to get the police to take my call

Judith Radtke - The person who was taking care of my cats

Stephanie Radtke - The daughter of the cat sitter who came to help her mom find the cats.



At 4:42 pm on Tuesday 11/6/2018, I got a call from my neighbor saying the police are going to knock my door down. The address 6301 W. Euclid Ave, Milwaukee, WI. I asked to speak with the police at that time to tell them that there was a key inside the mailbox right next to the door they were trying to break into. The police refused to talk to me until after they broke the door down, this occurred at 4:45 pm. The police unnecessarily caused damage to my house. If they would have taken a second to talk to me, they would have had access to my home in seconds. It would have taken them considerable less time to unlock the door than to break the door in.

I feel that the police acted negligently because the neighbor told them I was on the phone and they refused to talk to me until after they had broken down the door. I was in Oregon at the time and no one was home. I think that it was unacceptable that no one would speak to me until the damage was done.

I can get several of my neighbors who came to see what was happening to corroborate this claim.
