Dear Mr. Leonhardt:

On Thursday June 15, 2006 I reported my car stolen to the Milwaukee police department. In reporting the car stolen I signed a paper stating that the car was recovered and I nor my son could be located that at the time of the recovery that the car could be towed to the Milwaukee Tow lot located at 3811 West Lincoln Ave.

My car was located at approximately 11 A.M. on Saturday June 24, 2006. An officer made an attempt to contact us, but to no avail. The officer left a message on my voice mail (I still have it if you want to listen) stating that the vehicle had been recovered, the battery was missing, and it was involved in a very minor accident. He also stated that since we could not be reached, that the vehicle would be towed to the lot on Lincoln and that I should when picking it up refer to tow # 1261298.

On Monday June 26, 2006 I went to the tow lot to retrieve my vehicle at the tow lot. When told that the car was not driveable by the clerk at the window because it was missing the battery, I responded that I would have it towed. I paid the fees ( \$135.00) to regain possession of my vehicle (receipt # 167990 please see copies). I was then told and given a blue instruction sheet on where to locate my vehicle at 3701 West Hayes ( which no longer is accessible for non city tow lot employees). Upon seeing my vehicle dropped off on the street in a no parking area, I went to inspect the damage to it. Upon inspection I, my son and the tow truck driver that I called found that the entire guts had been removed from my car, not just the battery (please see photos).

Now my question is??? Was my car stripped by the tow truck driver that was used by the Milwaukee Police department, or was it stripped while on the tow lot. Now remember, the officer called and said that just the battery was removed. Because all of this damage was done it was not salvageable for me, so I had to pay the tow truck driver to tow it to the salvage yard.
