Dear Council Members:

We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.

Claimants, Thomas and Todd Schlicht, 3374 North 97th Place, Milwaukee, WI 53222 allege that the sewer lateral for their property located at 1821-1823 North Humboldt Avenue was not reconnected after the sewer along North Humboldt Avenue was relayed in or about Summer 2005. They claim damages in the amount of \$28,585.00.

Our investigation reveals the combined sewer was relayed in the area of this property. The Department of Public Works reviewed their records and they did not indicate any building sewer connections for this property. They also found no record of a building sewer permit for the property. Since the owners failed to notify the City of this sewer lateral, it can not accept liability and we recommend denial of this claim.
