As we have advised you under similar circumstances in the past, the Common Council has discretion to reject this claim or to pay it in whole or in part. Wis. Stat. § 895.35, *Bablitch and Bablitch v. Lincoln County*, 82 Wis. 2d 574 (1978).

This incident involved a field inspection stop.

The MPD initiated a criminal investigation in which the officers initially declined to give a statement without counsel. When they requested counsel, IAD compelled POs Mucha and Lutz to give statements concerning the incident after issuing PI-21s. Later, the MPD concluded that the officers were acting within the scope of their authority. Attached is a copy of a status report from Cmdr. Settingsgaard of IAD, and an itemization of the time and services rendered.
