3. On 08/29/20 at 1:11am, Milwaukee Police were dispatched to 7225 N. 76th Street for an entry to auto complaint. Investigation revealed that four vehicles were broken into and two firearms were taken. The incident occurred in the western part of the parking lot and there were no surveillance cameras, which would have captured the incident.
4. On 12/20/20 at 8:00pm, Milwaukee Police were dispatched to 7225 N. 76th Street for a trouble with subject complaint. Upon arrival, officers interviewed the applicant who stated that his staff had an altercation with a group of females who were attempting to engage in fights. The females left the scene before police arrival and a walk through of the tavern was conducted with no violation observed.
5. On 12/27/20 at 8:49pm, Milwaukee Police conducted a license premise check at 7225 N. 76th Street. Officers interviewed the applicant who said that he had no issues tonight, expressed gratitude for police presence, and encourages it.
6. On 05/02/21 at 6:43pm, Milwaukee Police were dispatched to 7225 N. 76th Street for a subject with gun complaint. Investigation revealed that security at the location were armed and that there was a large event taking place causing security to walk around the outside of the establishment. Security was cooperative with police and were considered to be doing a reasonable job.

7. On 06/21/21 a subject walked into the Seventh District to report a fight which occurred on 06/20/21 at 7225 N. 76th Street. The subject reported that a large fight erupted inside the tavern at 8:00pm and the police were never called. She had a video of the fight which was posted on Facebook. The following day, a District Four officer took a substantial battery complaint from that incident. Also, during the incident, several purses were found to be missing.
 8. On 07/04/21 at 9:21pm, Milwaukee Police conducted follow-up at 7225 N. 76th Street regarding the incident described in Item #7. Officers interviewed the applicant who stated that he was aware of the fight and said security broke up the two groups and someone called 911 for the injured female. The applicant told officers that medical staff arrived to treat the female and that he was unaware of the missing property. In the video of the incident, there was a subject seen with a firearm. The applicant identified the subject as an employee and said that he was no longer employed with the business. He also said that he has hired a new event staff, implemented a dress code, everyone (including employees) are checked for weapons before entering the establishment, and purchased a high-tech identification scanner.
 9. On 09/26/21 at 8:55pm, Milwaukee Police were dispatched to 7225 N. 76th Street for a shooting complaint. Investigation revealed that security kicked out a group of subjects and when they were outside, one of them retrieved a handgun and started shooting at the establishment. The group then entered their vehicles and started shooting at the building as they drove off. The actors performed two U-turns and shot at the tavern each time they passed. One person was shot during this incident. Officers were informed that the applicant was telling staff not to speak with officers and that security was seen leaving through the back door in order to avoid making a statement to police. The applicant did download the ID scanner information for officers. 37 casings were recovered from the scene.

10. On 12/13/21 at 1:30am, Milwaukee Police were dispatched to 7225 N. 76th Street for a theft complaint. Officers were met by the applicant who stated that the caller of the theft said security took her purse and he insisted that they did not. Investigation revealed that the caller took a pair of glasses she gifted to her x-boyfriend, who was security, and that security took her purse which contained the glasses. Police found the purse inside the business next to security and returned the glasses.

11. On 03/23/22 at 8:29pm, Milwaukee Police were dispatched to 7225 N. 76th Street for a "RES" complaint. Investigation revealed that a married couple were in an argument inside the parking lot of that location and one of the parties rammed their vehicle into the others causing them to fear for their safety.

NATURE OF CALL/ JUSTIFICATION

On Sunday, July 4, 2021, PO Khalid MAJEED and I (Squad 4467) conducted a tavern check at Prime Social Club located at 7225 N 76th St. This address is in the City and County of Milwaukee, WI. The purpose of this tavern check was to speak to the owner Odean TAYLOR regarding a fight that happened inside of the business on Sunday, June 20, 2021 in which a female sustained substantial injuries and property was missing.

INVESTIGATION

Upon arrival, I spoke with TAYLOR outside of the location in the front parking lot area. TAYLOR stated that he was aware of the fight that occurred on the above mentioned date. TAYLOR stated that on that day, two groups of females were engaged in a heated argument. TAYLOR stated that his security staff attempted to intervein but a fight broke out between the two groups. TAYLOR stated that the security staff broke up the fight and escorted on of the group of females out of the club while the other group remained inside until the first group left the property. TAYLOR stated that one of the females inside was injured and someone call 911. TAYLOR stated that medical staff arrived on scene to render aide to the female. TAYLOR stated that he was unaware of the missing property at that time.

I then spoke to TAYLOR regarding an individual who was seen on the fight video pulling out a firearm inside of the location during the brawl. TAYLOR identified the subject as "ACE" and stated that he was part of the event staff at Prime Social. (It should be noted that "ACE" is Antoine D MORTON B/M 03/20/1987) TAYLOR stated that he was unaware that MORTON was armed inside of the club as he was not part of the security staff. TAYLOR stated that he fired MORTON from the event staff after he was made aware that he possessed a firearm and had it on his person inside of the business. TAYLOR stated that MORTON was banned from entering the establishment due to his actions.

TAYLOR stated that since the incident that occurred on June 20, 2021, he has hired a new security company to secure the interior and exterior of the business when it is open to the public. TAYLOR also stated that he was a new dress code policy for anyone who wish to enter the club. TAYLOR stated that everyone included staff is checked for weapons prior to entering the building. TAYLOR ended the conversation by stating that he has purchased and installed a high tech identification scanner that captures an image on the id card and the individual who use the card to get in to the club.

This report is written by PO O'Neal STAMPS III, assigned to District 4, Late Power shift. I am currently assigned to Squad 4467 (Tavern Car) with PO Khalid MAJEED.

On Sunday, September 26, 2021 at approximately 8:55 pm, Officers responded to a SHOOTING complaint at Prime Social Club located at 7225 N 76th St. This address is located in the City and County of Milwaukee, WI

INVESTIGATION

On this day, the business was open and functioning as a nightclub with multiple patrons inside of the building. The contracted security staff were positioned inside of the business as well as the exterior parking lots. The following is a combination of statements from the owner of the security company as well as the victim of the shooting complaint:

STATEMENT from Shawn L. KIDD (B/M 06/03/1992)

KIDD stated that he owns his own security company called "North Star Private Police Agency. KIDD stated that employs at least 25 security guards but the roster does change depending on the event and the establishment.

KIDD stated that on the mentioned day, he staffed 14 security guards at the Prime Social Restaurant and Bar establishment on the interior as well as the exterior parking lots. KIDD stated that none of the security guards were armed and that they were just there for crowd control and security measures in case fights broke out.

KIDD stated that he arrived to the location sometime between 3 to 5 PM to check on his staffs and socialize. KIDD stated that he does not remember what time it was, but while he was in the back patio, he observed an individual with a black ski mask on. KIDD stated that the individual was with 7 to 8 other men who were also on the back patio area.

KIDD stated that he approached the masked individual who refused to take off the mask. KIDD then gathered 7 other security guards and confronted the masked individual to take off the mask. The individual once again refused causing KIDD and his team of security guards to escort the masked individual and his group of friends out of the bar. KIDD stated that the group was pushing and fighting with the security guards as they escorted the group out of the building. KIDD stated that while escorting the group out, the individuals were making threats to shoot up the bar.

KIDD stated that as the subjects finally left the club he observed suspect #1, who he described as a black male, 5'04" - 5'05", 130-145, dark complexion, slim build, with a short 1 inch afro, wearing a black t-shirt, black sweatpants, black shoes, and a black ski-mask, run towards a silver, grey, or golden, Chevrolet Malibu with tinted windows, parked near the hall for rent sign/bulletin board located at 7259 N. 76th St. and retrieve something from it. KIDD stated he observed the subject begin firing a firearm at the club. KIDD stated he believed that the firearm was a handgun based the suspects ability to retrieve and fire it so quickly. KIDD stated that the rest of the subjects then entered vehicles and also recovered firearms. KIDD stated that the other subjects entered unknown black sedans.

KIDD stated that the suspect autos then began driving onto N. 76th St. where they began firing at the East face of the building, striking the glass entry door. KIDD stated he then took cover so as to not get hit. KIDD stated the suspects then drove Southbound on N. 76th St. entered the left turn lane, and performed a U-Turn before heading back Northbound, and conducting another U-Turn near the Kiss Ultra Lounge 7330 N. 76th St. to come back Southbound. KIDD stated that the suspect vehicles passed the business again and fired at the business. KIDD stated that they repeated this U-Turn pattern one more time before fleeing the area. KIDD provided two additional descriptions for suspects. KIDD described suspect #2 as being a black male 5'10"-6'00" with a caramel complexion, medium build, Cardier glasses, a baseball cap, and possibly armed with a long gun (based on the sound of the gunfire coming from the firearm used by the suspect). KIDD described suspect #3 as a black male 6'00" 230-240 heavy set, with a caramel complexion, goatee, black t-shirt, black pants with red stripes, and a gold chain with a name tag styled pendant at the bottom. KIDD stated the other suspects were all black males but he couldn't provide descriptions. KIDD stated it was possible that his staff may have returned fire at the vehicles but he did not see if any did and as such would be unable to provide more information regarding.

The victim of this incident, Mursal O. ALI, (B/M, 01-01-95), sustained two through and through gunshots during this incident. ALI was picked up by a citizen and conveyed to District 4 for assistance then conveyed by squad to St Joseph's hospital before being transported to Froedtert Hospital for further treatment.

ALI was able to provide the following statement to Detectives regarding the shooting:

STATEMENT from Mursal O. ALI, (B/M, 01-01-95)

ALI, who was being treated in Trauma Room #B at Froedtert hospital stated he drove to the bar with his brother to stop in to see a girl. ALI stated as he was inside the bar a fight started with the security and other black males all wearing ski mask. ALI stated the fight went into the parking lot and the black males ran to their vehicles.

ALI stated they all had long guns and they started shooting. ALI stated he started to run to his vehicle which is a black Jaguar, with a temp plate of N311521. ALI stated his brother was waiting for him inside the vehicle as he was inside the bar. ALI stated as he was running he felt his left arm, side and back start hurting. ALI stated the security was shooting as well, because the shots were coming from behind him.

ALI stated he does not remember what the security guard was wearing, but knew the shooting was coming from that direction. ALI stated he ran to 76th Street and flagged down a lady who drove him to District 4 and they took him to the hospital. ALI stated he only visited the bar twice.

END OF STATEMENT

FOLLOW UP

Officer contained the scene and collected evidence on the exterior parking lot, N 76th St and also the identification card reader from inside of the business. Upon speaking with Odean TAYLOR who is the owner of Prime Social, he was unable to provide the paper copies of the business license but stated that he does have all the required licenses to be in operation.

I followed up with TAYLOR on Monday, September 27, 2021 and observed that he possessed the required paper copies of his business license. When asked why wasn't the licenses posted inside of his business, TAYLOR stated that he received his license renewal after paying the required fees and had the paperwork in his

This license premise report is written by PO David LETTEER, assigned to District 5, Late Power Shift Tavern Squad 5468, with PO Russell MACRAE.

On 09-27-21 at 8:48 p.m., a shooting was reported at the location 7225 N. 76th St., Prime Social Club, which is a licensed tavern in the City of Milwaukee.

During the course of the investigation, Sq. 5411 was dispatched to the shooting and requested PO MACRAE and I come to the tavern to assist with the licensed premise portion of the investigation.

Upon arrival, PO MACRAE and I were informed that the agent was telling his staff to not speak with the police and that officers at the scene were not able to get information about the business. We were informed that observed were several what appeared to be security people, wearing tac gear, leaving the back door and the scene. Officers were not able to stop the security people and get a statement from them. As well, just inside of the front door was an ID scanner, which the information was being requested from the machine, for further investigation.

As we walked to the business, we observed a bullet strike to the main entrance glass door. There were many cones in the parking lot, sidewalk and street area, indicating that there was a spent casing(s) at each cone.

We entered the tavern and met with the listed agent, Odean H. TAYLOR (b/m 03-26-79). As we were speaking with TAYLOR, we observed the ID scanner on a podium just inside of the entrance. We asked TAYLOR about the scanner and he stated the ID is scanned into the machine. The ID scanner then shows the person's ID and records their vital information onto the scanner. We asked if his scanner is connected to a network of scanners that allows other bars to see the information. This would be for a person causing trouble at Prime being escorted out for being disorderly, that person could be flagged, so if that person goes to another bar on the network, the other bar could know not to let that person into the bar.

TAYLOR gave us his information and I asked him if he could download the information from his ID scanner onto my thumb drive. TAYLOR complied and downloaded the information once, then once again in case the information did not download correctly.

Once the information was downloaded, I asked him to show me his tavern licenses. He walked me to where he had his licenses posted. I observed a Class B license and two other licenses (PEP and Food)

which all expired on 08-21-21. While looking at each license, I also observed that the agent name on the licenses had been crossed out with a magic marker. I informed TAYLOR that his posted licenses had been expired since 08-21-21, just over a month. TAYLOR stated that he had taken care of them, but did not have them with him. I then asked him why his name was blackened out with a marker, that upon inspection of the license, I needed to see who the agent of the license was.

TAYLOR stated he crossed out his name because he does not want to post his licenses and for people to see his name. He stated he does not want people to Google his name and find out information about him. He stated he has his management name on his licenses under his blackened out name, he believed that was good enough.

I asked TAYLOR if he had security working tonight and he stated he did. I asked him how many security people he had working and he was not sure. He stated he had about 20 to 25 employees working tonight, but was unsure of how many security he had scheduled tonight. TAYLOR stated he opened the bar at 12:00 p.m. and he closed the bar about 9:00 p.m. and the shooting was just prior to closing. TAYLOR stated he has security working entrances and exits. I had asked TAYLOR what weapons that his security carries, he stated pistols. TAYLOR went on to tell me that his security company is Guardian Security.

I asked TAYLOR who his bartender was tonight, but he could not tell me who or how many were bar tending. PO MACRAE did speak to TAYLOR later in the investigation and was able to gather bartender information.

I asked TAYLOR if he knew what happened tonight. He stated he was on the patio, when the gunshots were fired. He stated a a person had entered the bar and after entering the bar had put on a mask. TAYLOR stated his security had escorted the person with the mask out of the bar and shortly after security escorted the person out, is when the gunshots were fired.

I asked TAYLOR if he had cameras in the bar and he stated he did not have cameras. He stated that COVID almost shut his business down, so he did not install cameras on the property. TAYLOR has been running this business for a while, but again stated that he did not install cameras due to Covid and not knowing if the business would continue after Covid.

TAYLOR also had his occupancy certificate posted, from the city of Milwaukee, but not his sign indicating how many people could be on premise. We instructed him that needed to be posted and we pointed out places inside of the establishment that the occupancy could be posted. We also informed him that he could not cross out his name on his licenses and if he was concerned about the licenses, that he could post them in a place that they could be viewed or accessible if requested by police and not by the public.

See PO MACRAE's report regarding the staff working at the bar tonight.

I exited the bar and was informed that there may have also been bullet strikes to other buildings in the area as well. I was informed that 37 casings were recovered. The spent casings were 9mm and 223 caliber casings.

Due to some confusion, I contacted LIU and inquired about when the licenses were actually issued.

I was later informed that there was an error on the city's part, regarding the licenses and TAYLOR did have his licenses issued correctly, so the citation for having an expired license would not be issued. I called TAYLOR and left him a voicemail regarding this, informing him we would complete this report.

I did turn over the data recovered from the ID scanner to CIB, in order for them to further their investigation.
