This office is in receipt of your claim in the amount of \$717.60, relating to damage sustained to your property in September 2003, when police entered the premises at 3048 North 47th Street.

The Milwaukee Police Department records indicate they were participating in the execution of a warrant related to drug activity at this location. The records also note various papers were seized and turned over to the Wisconsin Department of Justice. If you wish to check on the status of these items you must contact that agency. Out investigation reveals that the police action taken in this matter was necessary and appropriate. Since the police were not negligent but rather were acting within the sphere of their responsibility, the City would not be liable. Accordingly, we are denying your claim.
