Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. DETAILS

Description

I have called the Police since May 2024 - currently and video/ voice recorded the noises in conjunction with the complaints. I HAVE 40 PAGES OF POLICE CALLS/COMPLAINTS AND VOICE/VIDEO CALLS FOR EACH DATE AND COMPLAINT. I WILL PROVIDE A FLASH DRIVE SINE I CAN'T UPLOAD IT ALL HERE. VEHEMENTLY, OBJECT TO GIVING THE BAR PLAY BY PLAY ANY LICENSE! The Play By Play Bar is operating by using the rear concreted area as an extended Bar space so they can get around their capacity. They installed 3 speakers to outside rear wall, erected permanent tables, umbrellas and chairs, have loud live bands, DJ's, multiple parties at 1 time (3 women celebrating their birthdays). They blast extremely loud noise- music, talking, screaming, placing orders, calling for drinks,

The Play By Play Bar is operating by using the rear concreted area as an extended Bar space so they can get around their capacity. They installed 3 speakers to outside rear wall, erected permanent tables, umbrellas and chairs, have loud live bands, DJ's, multiple parties at 1 time (3 women celebrating their birthdays) . They blast extremely loud noise- music, talking, screaming, placing orders, calling for drinks, inappropriate cursing and language unsuitable for children and consistent noises heard outside of the 50 feet Ordinance/Statue range; In addition, the smell of Marijuana; the traffic continuously circling between 39th St - Townsend St, and Fond Du Lac Ave while blasting music, loud mufflers, and talking trying to find parking spaces.; blocking driveways, parking in loading zones; dropping garbage, bottles, trash, used condoms on the street and side walk/ grass to neighborhood homes; patrons arguing inside walled deck area and spilling out onto the Bar parking lot and onto 39th St/ Concordia and Fond Du Lac Ave is a direct result of this Bar. Also, fighting in the parking Lot with 2 Security guards putting them onto the Street. I called 911. MPD caught several and issued citations. Numerous Bar Noise citations were issued. Bar owners and Manger turned up the music volume and used the microphone to discuss neighborhood homeowners in threatening Menacing language for calling the Police while blaming the calls on the WHITE neighbor. MPD witnessed several instances of the volume going up once they were warned to turn it off. The Bar owners use the outside area as a means to illegally expand their bar space. It is not used for patrons to simply eat a purchased meal. It is used all hours of the day and night until 2:30am as a full-service bar. Then the drunk customers sit on 39th St and Concordia Ave smoking and using drugs, having sex, and eating food - then throwing their garbage onto the street and sidewalks. The Bar operates in the cold weather by installing a Canopy Tent with heat, lights, tables, ... This area is even open and operating as a bar during the rain and thunderstorms. Even when the Manager/Owner turns down the music, I can still hear and record the noise of loud talking, laughing, screaming out, cursing and drunken partying.

I can't enjoy the quiet and peace of my property. I can't park in front of my house because I pay property taxes and street repair bills that they are responsible for damaging. My property taxes went up over \$30,000 in the last 2 years. My disabled Veteran brother who is dying from brain tumors, has to hear that doom-doom; doom-doom vibrating speakers/noise that contributes to his headaches and migraines. It is felt from the bar to the inside of my home. I live more than 50 Feet from the bar at 3344 N. 39th St.

This Bar has diminished the value of my property. There have been 3 fights that I witnessed since May 2024, when I started documenting the noise and calling the police for help. The police are too busy to service the call in a timely manner. Meanwhile, the neighborhood suffers. Play By Play Bar is operating illegally, outside the bounds of the law. They have simply disregarded the law and continued to operate in a manner that is disruptive, destructive, and detrimental to the neighborhood and the City of Milwaukee. The bar needs to

stay confined to the 4 walls of the building. The food court needs to be limited to eating and set hours. No drinking alcohol, dancing, smoking marijuana or using other drugs, No DJ, no speakers outside of the building blasting noise/ music to where any of the neighborhood can hear it- much less outside of the 50 feet Ordinance. I purchased this home in 1985. I moved here in 1986. There was a Bar called The Everglades that changed hands several times since then. I have never filed a complaint against any bar at this location because they have not been a problem for our neighborhood. It is the Play By Play Bar that refuses to operate by the rules and chooses to double down and do more illegal activity when advised of the issues. Some of the neighbors met with them before they were licensed. They have not kept any of their promises. They have made living here "a living hell!"
