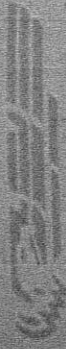

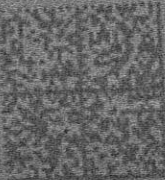

FENCES.

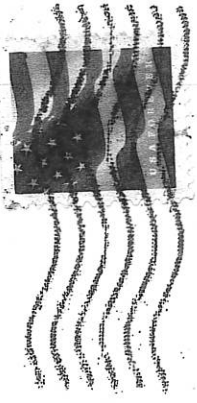
THE CITY WORKERS CAME OUT THAT
