Enclosed is a resolution recommending settlement of the above-referenced claim, which we ask be introduced and referred to the Committee on Judiciary and Legislation for their recommendation.

Claimant, Jeffrey Smith, through his attorneys, Gendlin, Liverman & Rymer, S.C., alleges that on October 6, 2023, while in the scope of his employment as a City of Milwaukee DPW employee, he was involved in a vehicle accident with an uninsured motorist, sustaining certain injuries and damages. The claimant has agreed to settle this claim for the amount of \$15,000.00.

Settlement of this claim is recommended based upon the reasons stated on the enclosed Settlement Draft Request from the law firm of Crivello, Nichols & Hall, S.C. This firm has been retained to administer the City of Milwaukee's uninsured motorist self-insurance plan.
