This is to notify you that on Tuesday, October 22, 2019, the City's Licenses Committee voted to recommend to the City's Common Council to renew with a twenty (20) day suspension the Class B Tavern and Public Entertainment Premises licenses for the premises located at 2079 S 8th St ("On My Way Home") based on the police report, and aldermanic and applicant testimony.

On October 24, 2019, you were mailed a true and correct copy of the findings of fact, conclusions of law, and recommendations of the Licenses Committee with respect to the Class B Tavern and Public Entertainment Premises licenses in which the Committee recommended that the license be renewed with a twenty (20) day suspension based on the police report, and aldermanic and applicant testimony. 


