Dear Mr. Jones:

We have received your claim in the amount of \$2,222.28, relating to damage to your vehicle from a loss on October 9, 2015 when you allege that a City truck made a u-turn from the right lane near 107th Street and Bradley Road and in the process collided with your vehicle which was in the left lane.

The Fleet Division indicates that our driver had the left turn signal on and was making the u-turn. You attempted to pass on the left side and collided with the truck. The Wisconsin Motor Vehicle Accident report notes that you were cited for following too close. The liability for this accident is upon you. As such, the City cannot accept liability for your damages. Therefore, we are denying your claim. If the City has damages to claim it may, in some capacity, contact you regarding them.
