This report is written by PO Amna OZEGOVIC, assigned to District Six, Early Shift.

On Thursday, April 17th, 2025, at 6:49 PM, Squad 6252 (Myself, in Full Milwaukee Police department issued uniform equipped with Axon body camera activated and in a marked squad) was sent to a Battery in progress complaint, which occurred at the address of 5037 S Howell Ave, which is located in the City and County of Milwaukee.

Scene:

Upon my arrival I observed a female, later identified as a victim of this incident, GUERRERA Monica (W/F, 01-12-1962) sitting inside of the lobby of Clarion Pointe hotel. I observed a white Chevy parked in front of the hotel and a white male, later identified as BUCCIARELLI Ian (W/M, 05-12-1978).

I observed a camera from the hotel facing towards the parking lot where the white chevy (according to Cad notes) was parked.

I observed the victim to be visibly upset, waving her hands and speaking in a very loud tone of voice. I observed her hair to be tied in a bun, with the strands of hair falling out of the hair bun, which indicated that her hair was pulled. I also observed victim's lower lip slightly swollen and redness around her neck.

Suspect was located sleeping in the front seat of the Chevy, in front of the hotel. There was an empty bottle of alcoholic beverage by suspects feet.

I observed the victim to be significantly smaller in size than the suspect.

Interview with the victim:

I spoke to GUERRERA inside of the lobby. GUERRERA stated she has been friends with BUCCIARELLI for approximately six months. GUERRERA stated she is not emotionally involved with him, but they spend time together and enjoy each other's company. GUERRERA stated that she spent the day hanging out with BUCCIARELLI at the Best Western hotel, who had been drinking all day. They were planning to spend a night at the Clarion hotel, where GUERRERA booked the room. Once she found out the hotel did not have a bathtub, GUERRERA went back into her vehicle and told BUCCIARELLI she did not want to stay there. The argument started between the two of them and GUERRERA told BUCCIARELLI she would call his brother. At that time BUCCIARELLI became angry and told her he was going to "break her neck".

GUERRERA stated that BUCCIARELLI just snapped and started hitting and "elbowing" her. BUCCIARELLI also pulled her hair and GUERRERA remembers hitting her head on the steering wheel of her vehicle.

During this altercation, BUCCIARELLI also grabbed GUERRERA's neck and choked her. At that time, GUERRERA was still able to breathe and did not lose consciousness. GUERRERA felt BUCCIARELLI pulling her lanyard she had around her neck. GUERRERA stated she did not remember how long this situation was going on, but remembers she was able to open the door and exit the vehicle.

While talking to GUERRERA, she stated her tooth was chipped and it was causing her pain. I observed trauma to upper right molar and observed it to be chipped. GUERRERA then showed me severe bruising on her left forearm, as well as bruising on her right forearm.

GUERRERA stated she never wants to see BUCCIARELLI again.

When I asked her if this behavior was out of BUCCIARELLI's character, GUERRERA stated she was shocked by his actions. GUERRERA stated it seemed like BUCCIARELLI just snapped.

Interview with the suspect:

P.O. Cartwright (Squad 6230) spoke to BUCCIARELLI who stated he was only hanging out with his friend, and nothing had happened between them. BUCCIARELLI was intoxicated and complained he was having a heart attack. BUCCIARELLI was taken into custody and conveyed by BELL 430 Ambulance to St. Francis hospital for medical observation.

I spoke to BUCCIARELLI at the St. Francis hospital, room 6. BUCCIARELLI stated he was set up by the wrong bitch.

Witnesses:

There were no witnesses to this incident.

I also spoke with the front desk attendant at Clarion, who was able to replay the surveillance camera.

The footage depicted the white Chevy and GUERRERA exiting the front driver's seat of the vehicle and depicts her walking into the hotel.

EITIAZ stated he is employed at the location and works at the front desk. EITIAZ stated a firearm was left inside Room #234, at the hotel. On scene, we went to room #234, and EITIAZ showed me where the firearm was located inside the room. The firearm was located on the television stand, behind a black Nike shoebox. At this time the firearm was seized regarding the investigation. EITIAZ provided contact information for the person who rented the room. This concluded my interview.

Interview- Xavier KENDERICK

On scene, I spoke on the phone to Xavier KENDERICK (b/m 04-21-00) 5474 Meadow Oaks Park Dr., Jackson, MS, 39211, (769) 233-1241. KENDERICK stated he was on his way home and was not in the Milwaukee area. KENDERICK stated he owned the firearm, and could not locate it prior to checking out of the hotel. KENDERICK was given my contact information and advised that property division would be contacting him. This concluded my interview with KENDERICK.
